The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that the products and services offered in the proposal response from PowerDMS, Inc., fall outside of the Requested Equipment, Products, or Services of the RFP. All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

Atlantic Diving Supply, Inc., is offering a selection of virtual reality simulators, training supplies, and related equipment for law enforcement and military applications. Their sales and distribution network can serve Sourcewell participating entities in the United States and Canada. ADS is offering significant discounts from MSRP.

CAE Healthcare Inc. is a manufacturer and service provider offering medical simulation training solutions and training services. They also offer a variety of training services, programming alternatives, and extended warranty options. CAE has a robust sales force throughout the United States and Canada. Their proposal reflects a solid discount off list price.

Doron Precision Systems, Inc., designs, manufactures, and services a line of driving simulators for law enforcement and municipality training and assessment needs. Equipment maintenance training, warranty service, and on-site maintenance contracts are available to maximize product operational time. Doron's sales and service force are available to Sourcewell participating entities in the United States and Canada. They are offering competitive discounts from commercial rates with available volume purchase savings.

Jahnke & Sons Construction, Inc., dba WHP Trainingtowers, designs, fabricates, delivers, and installs metal fire training towers and modular fire training systems in the United States, and supplies materials for installation by local professionals in Canada. They also provide maintenance and repair services, along with optional training courses for customer staff development. WHP is offering Sourcewell participating entities significant discounts from list pricing on materials and services.

Laerdal Medical Corporation is a manufacturer offering patient simulators, programmed scenarios simulation learning management systems and services to training students, medical professionals and first responders. Their direct sales and service teams are available to meet the needs of Sourcewell participating entities in the United States and Canada. Laerdal is offering competitive discounts from list prices.

Lexipol, LLC, is the provider of web-based interactive training learning management system solutions, credential tracking capabilities, and customization servers. Their sales and distribution network can serve participating entities in the United States and Canada. Lexipol's pricing reflects a significant discount off subscription list pricing.

LION First Responder PPE, Inc., manufactures simulation and training facilities, equipment, supplies, and props for use in the development of firefighting skills and techniques. They will leverage a distribution network that extends across the United States and Canada to serve Sourcewell participating entities. They are offering a solid percentage discount off list price.

Virage Simulation Inc. designs, manufactures, installs, and supports driving simulator equipment and technology.
