Open Air Structures and Accessory or Utility Buildings with Related Equipment and Services

The following advertisement was placed December 1, 2020 in Utah's *The Salt Lake Tribune*, in *USA Today*, in South Carolina's *The State*, and on the Sourcewell website www.sourcewell-mn.gov, Sourcewell Procurement Portal https://proportal.sourcewell-mn.gov, Biddingo, Merx, The New York State Contract Reporter www.nyscr.ny.gov, PublicPurchase.com, and December 2, 2020 in Oregon's *Daily Journal of Commerce*:
