The findings of the Proposal Evaluation Committee are summarized as follows:

Three proposals were rejected by Sourcewell and excluded from the evaluation process due to organizational conflicts of interest and procedural irregularities. The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that all other proposal responses met the scope and mandatory submittal requirements and were evaluated.

Convergint Technologies, LLC, is a security systems integrator offering electronic security, fire alarm, and life safety solutions in the US and Canada. They have a sizeable sales and service team supported by technology and emergency call centers to respond to Sourcewell participating entity needs. Convergint Technologies is offering a range of discounts from MSRP or list pricing on equipment, products, and services.

Johnson Controls Fire Protection, LP, provides fire protection and life safety systems and services in the US. They offer the Johnson Controls family of products and act as a reseller of a broad range of other fire and security brands. Johnson Controls Fire Protection trained technicians, installers, and professionals self-perform all service work. Their products and services are offered at competitive discounts from MSRP or from commercial hourly rates.

Siemens Industry, Inc., is the manufacturer and reseller of building automation, fire, and security products, and a provider of design, installation, repair, and maintenance services. Their sales and services teams are geographically dispersed across the US and Canada to deliver fire, safety, and security solutions to Sourcewell participating entities. Siemens Industry offers significant discounts from MSRP or list pricing to align with most favored customer pricing, and with standard shipping, delivery, and freight included in the continental US.

Stanley Convergent Security Solutions, Inc., designs, installs, monitors, and services integrated security and fire safety systems. With 110 branch locations, they can provide complete sales and service coverage across North America. Stanley CSS is offering a range of solid discounts from list pricing and national account labor rates.

Tyco Integrated Fire & Security Canada, Inc., offers the Johnson Controls family of products and acts as a reseller of a broad range of other fire and security brands. They have a large sales and service force to service Sourcewell participating entities across Canada. The Tyco Integrated Fire & Security Canada products are offered at competitive discounts from MSRP with services offered at significant discounts from local branch commercial rates.
