The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that the products and services offered in the proposal response from B-Line Tire and Auto Supply and Energy Mission Control (Fuse Carbon Technologies), fall outside of the Requested Equipment, Products, or Services of the RFP. All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

Element Fleet Corporation (Element Fleet Management) offers fleet management services with various financing options. Their sales and service networks are available to Sourcewell participating entities in the United States and Canada. Element's client portal, Xcelerate, leverages technology to provide actionable data to assist users in the management of their fleet. They are offering advantageous pricing terms in their proposal.

First Student provides on-demand maintenance for yellow school buses and white fleet vehicles. They strive for a customizable approach to school bus maintenance. First Student has locations across Canada and the United States. They are offering competitive pricing to serve Sourcewell participating agencies.

Lube-Tech offers advanced fluid technology lubricants and services in the United States. Using a proprietary asset management software, they provide preventative maintenance program setup, VMI activities, critical asset management tracking, remote telemetry monitoring, and more. Lube-Tech can also build, repair and service car washes and related detailing. They provide a standard warranty on equipment, parts and labor with an optional extended warranty. Lube-Tech offers pricing with a competitive discount to Sourcewell participating entities.

Nobel Computer Systems, Inc. (NOBEL Systems, Inc.) for over 20 years has specialized in serving local, county, and state government agencies with their auto impound management system including scenarios when dispatch is not required. They offer a discount with a tiered structure depending on the number of monthly dispatches or impounds.

Rynse, Inc. offers fleet access to nationwide car wash and detailing services across the United States. Their innovative, complementary software provides tailored billing, vehicle spend, data transparency and wash service flexibility for all vehicles. The level of service provided by Rynse is supported by established standards and quantifiable metrics to measure success. They offer a substantial pricing discount to Sourcewell participating entities with a choice of a prepaid model or price per vehicle.

Valvoline LLC offers a full-service preventative maintenance package that includes, but is not limited to fluids, filters, wipers, battery replacement, etc. Valvoline has an extensive network of locations to serve Sourcewell participating entities throughout the United States. They are offering better pricing than they typically offer other governmental agencies with a deeper discount from list price.

Vector Fleet Management, LLC was established in 1988. They are offering fleet management services to Sourcewell participating entities in the contiguous United States. They also provide a staffing service to address your fleet requirements, while prioritizing the retention of your existing employees. Pricing varies based on resource requirements and asset information.

Vehicle Management Solutions, LLC has been in business for over 46 years. They offer vehicle management solutions, including towing dispatch management, vehicle intake, secured storage, Incident management, and many other options. They also offer competitive pricing, with a discount on participating entities' annual towing volume and retail rates.
