

COMMENT AND REVIEW to the Invitations for Bid (IFB) on Indefinite Quantity Construction Contract GA-040820 – State of Georgia

IFB

Sourcewell issued the Invitation for Bid (IFB) on behalf of, and to provide Indefinite Quantity Construction Contracting (IQCC) services to, all current and potential Sourcewell Members (including all government agencies, education agencies to include colleges and universities, and non-profit agencies), within the State Georgia, as identified in the attached table of Counties and as shown on the attached map of the region. Sourcewell included multiple solicitations within the IFB with the intention of awarding multiple contracts in the State of Georgia.

Advertisement

The IFB was advertised in the Augusta Chronicle, Savannah Morning News, Albany Herald, Atlanta Journal-Constitution and Minneapolis Star Tribune on February 24, 2020, March 2, 2020 and March 9, 2020. It was also posted to the Sourcewell website and the Sourcewell Procurement Portal for viewing and document download/response from February 24, 2020 until the scheduled due date and time.

Pre-bid seminars were originally scheduled to occur in eight locations within the State of Georgia, with the dates, times, and locations identified in the solicitation advertisements. In response to public health guidance related to the COVID-19 pandemic, Sourcewell issued Addendum No. 4 on March 13, 2020, waiving the requirement of attendance at a pre-bid seminar. In addition, all pre-bid seminars were converted to an online conference hosted by Sourcewell on internet broadcast platform Webex. The pre-bid seminar was also recorded for on-demand viewing by any interested party.

The pre-bid webinar was conducted and broadcast on March 20, 2020, beginning at 1:00pm ET. A link to the on-demand recording was subsequently made available to all registered plan takers.

Bids

All Bids remained sealed within the Sourcewell Procurement Portal until the scheduled due date and time. Bids were electronically opened, and the list of all Bidders was made publicly available on the Sourcewell Procurement Portal, on April 8 2020, at 4:32:42 pm CT. Bid Evaluation Method

The bidders submitted five (5) adjustment factors for each contract opportunity within the area to the fixed prices in the Construction Task Catalog. Bidders who responded in all four geographical areas were eligible for Statewide Contract Awards. The ranking of Bidders eligible for Statewide Awards was determined by averaging the bidder's combined adjustment factor across all four geographical areas. The submitted bid adjustment factor. This combined adjustment factor was then used in determining the ranking of the bids.


