

COMMENT AND REVIEW

to the REQUEST FOR PROPOSAL (RFP) 063020 Entitled

School Buses with Related Accessories, Supplies, Parts, and Services

The following advertisement was placed May 12, 2020 in Utah's *The Salt Lake Tribune*, in *USA Today*, in South Carolina's *The State*, and on the Sourcewell website www.sourcewell-mn.gov, Sourcewell Procurement Portal https://proportal.sourcewell-mn.gov, Biddingo, Merx, The New York State Contract Reporter www.nyscr.ny.gov, PublicPurchase.com, and May 13, 2020 in Oregon's *Daily Journal of Commerce*:

Sourcewell, a State of Minnesota local government agency and service cooperative, is requesting proposals for School Buses with Related Accessories, Supplies, Parts, and Services to result in a contracting solution for use by its Participating Entities. Sourcewell Participating Entities include thousands of governmental, higher education, K-12 education, nonprofit, tribal government, and other public agencies located in the United States and Canada. A full copy of the Request for Proposals can be found on the Sourcewell Procurement Portal [https://proportal.sourcewell-mn.gov]. Only proposals submitted through the Sourcewell Procurement Portal will be considered. Proposals are due no later than June 30, 2020, at 4:30 p.m. Central Time, and late proposals will not be considered.

All Proposals remained sealed within the Sourcewell Procurement Portal until the scheduled due date and time. Proposals were electronically opened, and the list of all Proposers was made publicly available on the Sourcewell Procurement Portal, on June 30, 2020, at 4:46 pm CT. Proposals were received from the following:

The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that the products and services offered in the proposals received from Industrial Power LLC, NS Corporation, Paccar Parts, and Transport Equipment Inc, fall outside of the Requested Equipment, Products, or Services of the RFP. All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

Blue Bird Body Company is a manufacturer of Type A, C, D and activity school buses offered in a wide range of engine types, including alternative fuel and electric powered options. Their dealer network in the US and Canada is available to serve a broad cross-section of Sourcewell Participating Entities. Blue Bird Body Company offers a significantly discounted price on buses and optional equipment.

IC Bus, LLC, manufactures Type C, D and multi-function school activity buses in gasoline, diesel or propane engine configurations. They will serve Sourcewell Participating Entities through a network of dealer locations across the US and Canada. IC Bus pricing reflects a considerable discount off list price on buses and optional equipment, with additional quantity and volume discounts available.

Lion Buses, Inc, is a manufacturer, dealer and service provider for all-electric powered Type A, C, and D school and activity buses. They have available training classes, service plans, and extended warranty options to meet Participating Entity needs. The pricing offered by Lion Buses reflects a discount from list price structure, with an opportunity for volume or quantity discounts.

Thomas Built Buses offers sales and service of Type A, C, and D school buses through an independent dealer network covering all 50 states and 9 provinces. They have ten parts centers, a network of Detroit engine distributor locations, and hundreds of satellite service support facilities in the US and Canada to promptly meet the service and warranty needs of Participating Entities. The pricing on school buses and optional equipment represents a significant discount from Thomas Built Buses standard prices.

For these reasons, the Sourcewell Proposal Review Committee recommends award of Sourcewell Contract #063020 to:
