IT Managed Service and Staff Augmentation Solutions

The following advertisement was placed May 25, 2021 in *USA Today*, in South Carolina's *The State*, in *The Oklahoman* and on the Sourcewell website www.sourcewell-mn.gov, Sourcewell Procurement Portal https://proportal.sourcewell-mn.gov, Biddingo, Merx, The New York State Contract Reporter www.nyscr.ny.gov, PublicPurchase.com, and May 26, 2021 in Oregon's *Daily Journal of Commerce*:

Sourcewell, a State of Minnesota local government unit and service cooperative, is requesting proposals for IT Managed Service and Staff Augmentation Solutions to result in a contracting solution for use by its Participating Entities. Sourcewell Participating Entities include thousands of governmental, higher education, K-12 education, nonprofit, tribal government, and other public agencies located in the United States and Canada. The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that all proposal responses met the scope and mandatory submittal requirements and were evaluated.

22nd Century Technologies, Inc. (TSCTI), is a certified MBE providing managed service and staff augmentation services in the US and Canada. Their experience includes delivery of services to a wide range of government and education sector customers by size and geographic region. TSCTI offers Sourcewell participating entities a discounted line-item rate structure with an additional volume discount available.

CDW Government, LLC, offers direct and third-party IT professional and managed services through its engineering, support, and service teams, a variety of "X-as-a-Service" solutions, and contract, contract to hire, and full-time hire staff augmentation solutions. They have 32 service locations in the United States and nine offices in Canada. CDW-G pricing reflects a combination of discounted line-item pricing and solid percentage discount from catalog pricing, as applicable.

Computer Aid, Inc., is a full-service IT managed service and staff augmentation service provider. Their contingent labor services are available through an integrated ecommerce model and the delivery of managed services is supported by service level agreements tailored to meet participating entity needs. CAI develops Sourcewell participating entity pricing by reference to regional tier rates supported by current labor compensation data gathered by the Economic Research Institute.

Infojini, Inc., is a staff augmentation service provider and certified MBE providing on-site, remote, onshore, and offshore delivery options. They have over 700 employees situated in a network of geographically dispersed office locations across the US and Canada, augmented by subcontractors as needed. Infojini pricing encompasses a broad range of job titles at competitive hourly rates, with prompt payment and volume discounts available.

Judge Technical Services, Inc., delivers IT staffing, consulting, and training solutions through its own employees and contractor associates, including many diverse and disadvantaged business partners to meet participating

Judge Technical Services pricing reflects a tiered methodology by contractor level of experience, with available full-time hire and contract-to-hire pricing arrangements.
