

## **NBA** draft

problems sidelined Ja Morant, the Grizzlies were one of the ascending teams in the West, winning 51 games in 2022-23 and 56 in 2021-22.

### **UConn**

Huskies coach Dan Hurley may have turned down overtures from the Lakers, but his team still had a massive imprint on the draft, in particular early on. UConn had two players selected in the lottery for the first time since 2012, when Andre Drummond (ninth) and Jeremy Lamb (12th) were drafted. This time the Huskies actually had two players picked in the top 10, with Stephon Castle going to the Spurs at No. 4 and Donovan Clingan going to the Trail Blazers at No. 7.

#### **France**

Zaccharie Risacher and Alex Sarr went 1-2 in the draft, marking the first time two French players were selected with the first two picks. Tidjane Salaun was drafted sixth, marking the first time three players from a country other than the U.S. were selected in the top 10. New York took another Frenchman, Pacôme Dadiet, at No. 25 in Wednesday's first round. There's a French renaissance happening in the NBA right now with rookie of the year Victor Wembanyama of the San Antonio Spurs and impressive rookie Bilal Coulibaly of the Washington Wizards. This draft marks the

third consecutive year that at least four French players were drafted.

### **Washington Wizards**

Washington started the night with two first-round picks - No. 2 and No. 26. But an aggressive front office, led by president Michael Winger and general manager Will Dawkins, made a trade with Portland to get another lottery pick at No. 14. The Wizards selected Alex Sarr second, Carlton "Bub" Carrington 14th and Miami's Kyshawn George at No. 24 after a minor trade with the New York Knicks. Now, the Wizards need those picks to work, but it's clear the Wizards spent considerable time investing in this draft as part of the franchise's major rebuilding effort.

### **LOSERS Brooklyn Nets**

The first round of the draft was at the Brooklyn Nets' Barclays Center, and the Nets did not have a first-round pick. They also didn't have a second-round pick going into Thursday; however, they could trade into the round. The Nets traded their 2024 first-round pick to Houston as part of the deal that sent James Harden from Houston to Brooklyn in 2021. That 2024 pick Houston received in the deal ended up being the No. 3 pick, and the Rockets selected Kentucky guard Reed Sheppard.

### **G League Ignite**

The G League Ignite had two players selected in the lottery (Ron Holland at No. 5 and Matas Buzelis at No. 11) and last season the Ignite's Scoot Henderson went No. 3. However, the 2023-24 season was the last season for the Ignite, which served as a place for players who weren't interested in college or playing internationally to develop and make money. However, NIL rules altered the college landscape and NBA Commissioner Adam Silver decided to shutter the Ignite. "We got to the point now with Team Ignite where frankly we felt it didn't make sense to compete against these top college programs, where in many cases have better facilities, top-notch coaching, charter aircraft, etc.," Silver said at the start of the NBA Finals on June 6.

#### **Too many bigs for** the Portland Trail Blazers

This isn't about the selection as much as it's about roster construction. Former UConn center Donovan Clingan should be an instant rim protector, and all signs are that his offensive game should continue to improve at the next level. He is 7-foot-2 and 282 pounds and averaged 2.5 blocks in his two seasons with the Huskies, both of which resulted in national championships. The issue is that Portland is on the hook for another 7-footer, Deandre Ayton, for nearly \$70 million over the next two seasons, according to Spotrac.com. While Ayton's offensive game is more refined than Clingan's at least at this stage, their style of play is rather similar, almost making the Clingan pick redundant. Plus, as NBA teams increasingly turn to speed and athleticism to push pace in the name of scoring, having two bigs like Clingan and Ayton may make

the Blazers offense a touch deliberate and plodding.

### Too many guards for the Sacramento Kings

Like the note about the Blazers above, this is all about roster construction. Devin Carter may actually end up as one of the better picks of this draft, going to the Kings at No. 13, but it creates a massive logjam in the backcourt. Sacramento has star point guard De'Aaron Fox and shooting guard Kevin Huerter starting, with Sixth Man of the Year runner-up Malik Monk, Keon Ellis and Davion Mitchell all on the bench. Ellis stepped into the starting role down the stretch and played well after Huerter (shoulder) and Monk (right knee) were sidelined with injuries. The odd man out would appear to be Huerter, who is under contract for the next two seasons at nearly \$35 million, per Spotrac.com. Now, Kings general manager Monte McNair has to juggle. Even then, the most likely outcome is for one or more of these talented guards to waste away on the bench, barring injuries.

### Winner and loser **Dalton Knecht**

Tennessee shooting guard Dalton Knecht was a projected lottery pick even top 10 in some mock drafts – but fell to No. 17. He also "fell" into a good position with the Los Angeles Lakers. He gets to play alongside LeBron James and Anthony Davis, and for new Lakers coach J.J. Redick, who embraces the modern NBA and 3-point shooting. That should work well for Knecht.

have put together the most stunningly robotic three-year run we've seen from a 6-foot-7 slugger. Well, he's halfway to a 2022 repeat, and that's not bad.

### **Gunnar Henderson: 5.9 WAR**

Sure, it's not quite as fun to toss WAR out there at the halfway mark, since multiplying by two just isn't quite that simple. Yet it's still a staggering number through 80 games - particularly when you consider that no player has produced a 12-win season, as computed by Baseball-Reference, since Carl Yastrzemski's 12.4 WAR season in his Triple Crown-winning 1967 campaign.

Yet Henderson's first half has been that good.

His 26 home runs are second to Judge's 30, one ahead of Shohei Ohtani. Henderson has 13 steals in 14 tries, a 1.005 OPS, a .387 OBP. His 70 runs lead the majors, which you might expect from a guy who hits leadoff most days. Yet he's on pace to drive in 114 runs, too.

All this in a 22-year-old shortstop who, by the way, is tied for 11th in outs above average.

Henderson has shown little signs of slowing and looks like a strong bet to ioin Mookie Betts (10.7, 2018), Judge (10.5, 2022) and Mike Trout (10.5, 2016) with the lone double-digit WAR seasons in the past decade.

Spoiler alert: Those guys all won AL MVPs in their 10-WAR seasons.

### Paul Skenes: 11.8 K/9, 7.63 K/BB

The reigning No. 1 overall pick and the

most exciting pitching prospect in 15 years has something of an incomplete grade, since he was summoned in May and his stats after eight starts are more befitting the one-fourth mark than the halfway point.

But those stats are really, really good. Never mind the 61 strikeouts in 46 1/3 innings, which projects to 244 punchouts in a 32-start season. Rather, it's both his dominance and command that bode so well for the 6-foot-6, 235-pounder from LSU.

If he pitched sufficient innings to qualify, Skenes' strikeouts per nine would rank third in the majors, behind Garrett Crochet and Tyler Glasnow, and his strikeout-to-walk ratio fourth. It's even more impressive when you consider he's work-shopping five pitches at the big league level, varying their usage significantly from start to start - though playing all of them off his 99-mph fourseam fastball isn't a bad base from which to build.

In most plate appearances, fastballsplitter (or, splinker, as they like to call it) is more than enough. Yet he can also get swings and misses in the zone on his slider, which he throws 16% of the time with a 26.4% whiff percentage that's not far off his 30% rate on the fastball.

It's all added up to a 2.14 ERA, a 2.50 FIP and, most important, a 6-2 Pirates record in games he starts. Appointment viewing, indeed.

### **Shohei Ohtani: 48 extra-base hits**

We took a peek at Ohtani's numbers during our quarterly checkup, and while they're not quite as sublime as they

were in May, the Los Angeles Dodgers slugger can still reach some astounding feats of strength.

With 25 homers through 82 team games, the first 50-dinger season of his career is within reach, and he's on pace to top the career-high 46 he slugged in 2021. Yet his 25 homers, 21 doubles and two triples give him a shot at a littleknown milestone: 100 extra-base hits.

There have been just 13 seasons of 100 extra-base hits, with eight of those coming in 1937 or earlier. The only five since 1948 came in the heart of the offense-fueled steroid era. Ohtani is spraying the ball into alleys and over walls during a year in which the league batting average of .242 and OPS of .704 would be the lowest since 1968 and 1992, respectively.

Little wonder that he leads the National League in adjusted OPS (190). And batting (.322), slugging (.643) and OPS (1.045). Yeah, the guy pretty much wakes up and makes history.

### Phillies, Yankees, Guardians, Orioles, Dodgers: 50-53 wins

Yeah, so this is why the pennant stretch might be a bit of a yawner. Five teams are on pace for 100 wins, with the 50-win Orioles just a game behind the Yankees to set up the most compelling race of the second half.

But the Braves may lack the consistency to chase down the Phillies in the NL East. The Guardians, behind Jose Ramirez's 44-homer, 150-RBI pace and rookie manager, are eight games up on the streaky Twins. The Dodgers should have a double-digit lead by the All-Star break.

Enjoy the greatness, even if it saps some tension from the final three months.

An exhilarating Euro 2024 has already produced so many instant classic moments. It really might be one of the best iterations of the tournament that we've ever seen. The round of 16 alone was a powder keg of drama.

From Cristiano Ronaldo's emotional redemption against Slovenia to a Turkish hero standing on his head to make one of the greatest saves in history, we're seeing some extremely high-level soccer across the pond. And I, for one, hope it continues in a quarterfinals slate that looks positively stacked with quality from top to bottom.

Here's what I'm forecasting for each game of the Euro 2024 quarterfinals.

### Friday, noon EDT, Fox: Germany vs. Spain

Here, we have an epic matchup featuring the two best and deepest teams in the tournament in the quarterfinals. A matchup that unfortunately won't happen in the final but very well may likely decide the overall champion. Who's got it better than us?

I think this is the ultimate toss-up. On the one hand, Germany is the host nation, and the home-field advantage in this kind of international tournament is massive. I also love Jamal Musiala and Toni Kroos together, who might comprise the best midfield duo in these Euros. Usually, the team with the stronger, more experienced midfield wins.

Still, it's so hard to overlook Spain's top-end talent and depth. Whatever questions there were about 16-year-old phenom Lamine Yamal, they no longer exist. This impeccably poised young man is already giving off future "Best In The World" vibes. Fellow youngster Nico Williams has been a revelation, and the savvy Rodri might be the finest player alive right now.

The Germans are a machine. But so are the Spanish. It feels like they have a gear no one else can reach. Either way, we're in for quite a treat.

Prediction: Spain 2, Germany 1

### Friday, 3 p.m. EDT, Fox: France vs. Portugal

Friday's doubleheader closes with a (slight) battle of the Iberian Peninsula.

In one corner, you have Kylian Mbappe and superpower France, which has played in each of the last two World Cup finals but has advanced past the Euro quarterfinals just once this century. On the other, you have Portugal, the team that coincidentally beat France in the 2016 Euro final as it seeks out one last international title for the legendary Cristiano Ronaldo.

While both talented teams have been kind of disappointing so far, there's no denying this game is flat-out dripping with intrigue.

The French may have entered this tournament as a favorite, but their lack of consistent offense scares me. Through four games, France has scored three goals, two of which were deflections off the opposition. Mbappe and Co. haven't had trouble generating opportunities, but seemingly no one can finish. The worst part is that France has yet to play an imposing backline.

On the flip side, Portugal has one of

the deeper rosters at these Euros, but it's been sleepwalking lately. Georgia's group stage upset was a harbinger of things to come, at least in an anticlimactic penaltykicks win over Slovenia in the round of 16. Ronaldo's mindset should be the most disconcerting situation for Portugal. Even while he's still a good player, it felt like Ronaldo was forcing the issue far too much against Slovenia rather than letting his teammates make more plays.

At this point, I don't trust either the French or Portuguese to live up to their respective high expectations. However, I have more faith in the French, who are still a better team on paper.

Prediction: France 1, Portugal 0

### Saturday, noon EDT, Fox: Switzerland vs. England

Another tournament favorite, England, has sputtered while trying to avenge its loss in the 2020 Euro final. If not for miraculous heroics from Jude Bellingham and Harry Kane, this uninspiring iteration of the Three Lions would've been eliminated by Slovakia in one of the biggest upsets in international soccer history. I don't know what's wrong with a team

with a constellation of stars, but it seems to be missing that extra special flare necessary to win it all.

Switzerland is the furthest thing from "cupcake." The battle-tested Swiss took Italy apart without mercy in the round of 16. This is a generation of Swiss soccer that has now firmly established itself as a European power with a round of 16 appearance in 2016 and two consecutive quarterfinals berths in 2020 and now 2024. Captain Granit Xhaka is one of the more underrated midfielders in the world, while every member of the Swiss starting 11 plays in one of Europe's big

Most important, Switzerland plays together in perfect harmony and unison, unlike its quarterfinals opponent. It has the look."

Prediction: Switzerland 1, England 1 (Switzerland 5-4 on penalties)

### Saturday, 3 p.m. EDT, Fox: **Netherlands vs. Turkey**

It wouldn't be a proper European championship without a perennial disappointment having to ward off a Cinderella

The Netherlands is arguably the most famous international soccer power that consistently falls short of expectations. The only championship the Dutchmen have ever won was a 1988 European title. The 2024 iteration is a solid group overall, led by center-back Virgil van Dijk. Still, outside of Cody Gakpo, it mostly lacks the expected firepower you'd hope for from a heavyweight.

Turkey, meanwhile, really shouldn't be here. I don't mean that in the sense that the Turkish don't deserve this unexpected European success. They do, and we love to see it. I literally mean that if not for the fingertips of Mert Gunok, Turkey would probably not have been playing in these quarterfinals.

What a remarkable story.

As vulnerable as the Netherlands seems, the slipper eventually stops fitting for most Cinderellas. Maybe the unthinkable happens. Greece in 2000 and Portugal in 2016 similarly faced long odds before winning their titles.

Prediction: Netherlands 3, Turkey 1

# Copa América: Vying to challenge Argentina

Copa América is down to its final eight teams. Only three games stand in each team's way to the final on July 14 in Miami Gardens. Here are USA TODAY Sports' Copa América quarterfinal power rankings:

### 8. Panama

No team in the quarterfinals allowed more goals in group play than Panama (5). Panama can at least hang its hat on reaching the knockout stage.

### 7. Ecuador

The math worked out in Ecuador's favor, relying on a 3-1 win over Jamaica and a scoreless draw with Mexico. But let's be frank: Ecuador doesn't stand a chance against Argentina.

### 6. Canada

Brazil has the talent, but the players haven't been able to put it all together outside of their 4-1 win over Paraguay. To make matters worse, reigning Champions League winner Vinicius Junior of nant play owning nearly 60% of posses-Real Madrid won't be able to play in the quarterfinal because of two yellow cards incurred in the group stage. Can Brazil's other standouts such as Rodrygo and Raphinha step up?

### 4. Venezuela

Venezuela won all three of its matches and allowed just one goal to Ecuador in its first match. It has scored six goals, tied for second.

### 3. Colombia

Colombia nearly beat Brazil on Tuesday, if not for a goal disallowed by VAR and a borderline offside call. Still, the Colombians have been on a roll, unbeaten in their past 26 games. James Rodriguez has been instrumental, leading all players with three assists on Colombia's six goals. And Colombia's ball-domision bodes well.

### 2. Uruguay

Uruguay has exceeded its expected goals (6.0) with nine scored during the tournament, two each by Darwin Núñez and Maximiliano Araújo. Like Argentina, Uruguay has seen only six shots on goal from opponents, with its only goal allowed coming in the closing minutes of a 3-1 win over Panama. Uruguay also has a 2-0 win over Argentina last November in Buenos Aires.

### 1. Argentina

Lautaro Martinez leads all players with four goals scored. Dibu Martinez is one of the best international goalies and was the only player with three clean sheets in group play. And, of course, there's Lionel Messi.






