Fiat Chrysler-PSA deal: fewer brands, more?

But merger could also create company large enough to compete.

MILAN — Automobile shoppers across the globe are likely to see fewer vehicles and brands if the merger of Fiat Chrysler and France's PSA goes through, but the new company will be big enough to compete in a fast-changing business that requires vast sums of money to develop autonomous and electric vehicles.

The two companies announced the merger Thursday that, if finalized, will create the world's fourth-largest auto company worth \$50 billion. But PSA will have the upper hand in the deal, with its cost-cutting CEO Carlos Tavares in charge and PSA controlling the new company's board.

Both companies still have to agree on final provisions, but the deal could close by the end of the year.

Tavares, who used to run Nissan in the Americas and knows the U.S. market well, will not shy away from trimming unprofitable models and brands. He's credited with turning around the Opel and Vauxhall brands in Europe,

perennial money loser that PSA acquired from General Motors two years ago.

Bernstein analyst Max Warburton wrote in a note to investors that he's confident Tavares can pull off combining the companies.

"Tavares' playbook has been to take on loss-making businesses and fix them, rapidly," Warburton wrote. "We believe he can achieve something similar at Fiat in Europe." He called Tavares the "world's most frugal auto executive."

Fiat Chrysler CEO Mike Manley was left without a title in the combined company. He'll take a senior leadership position, the companies said, but his role in the new business was not immediately clear.

Tavares will hold the lth

and SUVs are built. Platforms normally cost \$1 billion each to develop, and consolidating them is where most of the savings would come.

Ramsey doesn't foresee an immediate impact when the companies combine, but said there will be in three or four years as new vehicles are developed.

"They need to sit down and figure out where are their overlapping platforms and how that product is going to merge over time," he said.

In the U.S., Tavares won't be afraid to go after underperforming models and brands, said Ramsey. A top candidate for elimination would be the Chrysler brand, which has

divided to only two models, a minivan and a car, he said.

Both companies will save money later as more platforms are consolidated and they jointly develop battery-powered vehicles, he said.

Fiat Chrysler, meanwhile, continues to struggle in Europe, where executives acknowledge that the model lineup is tired and where plans to relaunch the premium luxury brands Alfa Romeo and Maserati have so far foundered.

"When you do a merger of this type, surely there is a winner and that is the shareholders," said Francesco Zirpoli, of the Geneva-based automotive and mobility innovation at Venice's Ca' Foscari University.

Olbekson has 'passion for the work'

← ST. ANTHONY from D1apolis American Indian Center (MAIC). Fittingly, he has produced the plans for a \$15 million overhaul that could begin as early as 2021. Olbekson can remember one of his uncles roofing the new MAIC in 1974-75.

After college, he worked construction before earning a master's degree in urban design from Harvard University.

Olbekson, who works for Cunningham Group as an architect as well as his own Full Circle firm that focuses on Indian projects in Minnesota, reservations in Minnesota and around the country, also is chairman of the MAIC and the Native American Community Development Institute, also on E. Franklin.

He's designed several new and refurbished housing projects along the Franklin corridor. He uses Full Circle as the vehicle for a lot of the Indian projects because he can take his time and charge next-to-nothing for his work.

"The thing that makes my heart sing is seeing people gather, listening to their vision, building community and a building that makes them proud," Olbekson said. "The cultural corridor including outdoor spaces, is based on a shared vision. It's not just a building. Culture emerges from the process of us working together and includes traditions, food, music and art."

Those are the start of an improving economy that can be seen from the under-construction Mino-bimadizwin housing project at Cedar and Franklin, developed by the Red Lake Band of Chippewa and designed by Olbekson. It extends to the Anishinabe-MAIC outdoor park, the refurbished NACDI headquarters, including an art gallery and small restaurant and

other projects in which Olbekson has been involved.
 "Sam has a passion for the work and he is very artistic and

he listens, develops consensus and develops the concepts to design," said Tom Hoskins, 70, a veteran Cunningham architect who has worked on projects for the Mille Lacs Band of Ojibwe for nearly 30 years and with Olbekson around the country for the last decade.
 "Sam also is a great signifier. Every tribal building tells the story of a tribe's vision. The story of the tribe brought forward to make them proud of their past. Sam shows that in buildings and landscape."
 "And we are looking for other Native American architects and designers. We've always been community minded. And we are happy to do pro bono work to advance those ideas."

Small firms at risk of being hacked

ST. ANTHONY from D1 customer data several years ago that led to the resignation of its CEO.

No surprise that last month's Cyber Security conference spent an afternoon focusing on "Cyber Security Plan Basics to Protect Small to Midsize Business."

"Most small businesses aren't there to do what they do," said Eric Ebner, a founder of St. Paul-based Protocol 46, a data-security firm. "But it's 2019. Doctors don't make house calls with black bags anymore either. You also have to be something of a tech company to do business."

The former Minnesota National Guard intelligence analyst, an Iraq war veteran who later focused on cyber-threats against Minnesota government and critical infrastructure, said the cost of an effective security program doesn't have to break the bank.

"We provide an enterprise-grade solution for small businesses for a price that's less than \$2.35 a day," he asserted. "Security for less than a cup of coffee daily."

Ebner, Manning and Nancy Libersky, district director of the U.S. Small Business Administration in Minnesota, also stressed that employers need to engage employees in preventive defense.

Libersky advised conferees that her agency offers a free audit to small businesses at www.sba.gov/cybersecurity. The SBA helps owners assess business risk, explains common threats, cybersecurity best practices and also lists related trainings and events.

"The SBA sends out a 'phishing' e-mail check on employees on a regular basis as a test," Libersky said, adding that awareness has been uneven but improving. "The training is mandatory. Small business can spend a boatload or not too much for good cybersecurity."

The stakes are high in terms of business disruption and financial losses. An SBA survey recently found that 88% of small businesses "feel vulnerable." The FBI reports that there were 42,000 data breaches worldwide last year. And 43% targeted small businesses.

Manning has become something of an evangelist. "We were vulnerable because we didn't have [double ID authentication] to get into company phones and computers," she said. "I've got clients who I talk until I'm blue in the face about this. You have to take security measures to protect yourself and your business."

The Federal Communications Commission has 10 Cyber Security Tips for Small Business at www.fcc.gov/general/cybersecurity-small-business. They include training employees in security principles, including how to handle and protect customer information and other vital data; keeping "clean machines" with the latest security software, web browser and operating system — the best defenses against viruses, malware and other online threats. Also, firewall security that prevents outsiders from accessing data on a

private network. Controlling physical access to computers and creating user accounts for each employee also is important.

And require employees to use unique passwords and change passwords every three months. Consider implementing multifactor authentication that requires additional information beyond a password to gain entry.

Phil Schenkenberg, a partner at Briggs and Morgan, said

there is a financial incentive for business owners, beyond preventing delays and operating losses caused by security breaches and other security threats.

He has seen situations where buyers of companies have negotiated lower-than-demanded prices for good companies, after it was learned their data was compromised or stolen by a cyber breach.

In some cases, buyers will require a cybersecurity audit

or hire a hacker as part of the deal to attack the target organization to explore vulnerabilities.

Buyers increasingly want proof that any vulnerabilities are long fixed or they will demand a significantly lower price.
