



THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #TX-GC-GC-021920-CCT, is effective upon the date of the last signature below.

Sourcewell and CORE Construction Services of Texas, Inc. The following is adopted as the new CTC for the Contract effective March 6, 2023:


