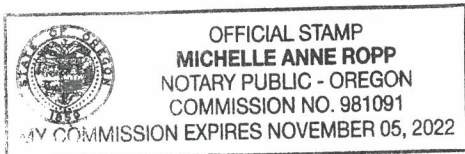

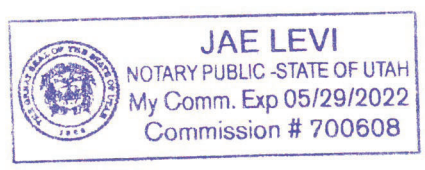

Options, obstacles to resuming NBA

NBA commissioner Adam Silver acknowledged last week that the 2019-20 season might not resume because of the coronavirus pandemic.

"Of course it's possible," Silver said on TNT's "Inside the NBA." "I just don't know more at this point."

With the Centers for Disease Control and Prevention on Sunday recommending no gatherings of 50 people or more for at least the next two months, the NBA might be getting closer to the possibility of a season with no championship awarded.

The NBA office is working overtime to put together scheduling models that account for playing some remaining regular-season games or no regular-season games and starting the playoffs when it is deemed safe to resume games.

The league wants to salvage the season, and it is going to operate under that idea until it plays games again this season or is forced to cancel the season.

Hundreds of millions of dollars are at stake. Yet in unprecedented times, health and safety will guide decisions.

What would be playoff seeding if the league resumes and jumps right into the postseason? The league likely would use standings as they are today. With the Bucks owning the best record in the Eastern Conference and the Magic in eighth place, that would be a first-round matchup.

If teams were tied, it stands to reason the NBA would use its normal tiebreaker system to determine seeding. As the standings are today, these would be the first-round matchups:

East: No. 1 Milwaukee vs. No. 8 Orlando; No. 2 Toronto vs. No. 7 Brooklyn; No. 3 Boston vs. No. 6 Philadelphia; No. 4 Miami vs. No. 5 Indiana.

West: No. 1 Los Angeles Lakers vs. No. 8 Memphis; No. 2 Los Angeles Clippers vs. No. 7 Dallas; No. 3 Denver vs. No. 6 Houston; No. 4 Utah vs. No. 5 Oklahoma City.

One thing to consider: NBA executives are wondering how much time

teams will have to practice before playing a game if the season restarts.

What is the latest realistic time the NBA can return and finish the season? Two months from now means the NBA could possibly restart in late May and have approximately six to eight weeks of playoffs concluding in mid- to late-July.

The NBA and its teams will also need to consider events, such as concerts, booked for arenas during the summer and how easy or difficult it will be to reschedule those events and create arena availability for playoff games.

Speaking of arena dates, the Democratic National Convention is scheduled for July 13-16 at the Bucks' Fiserv Forum, another potential complication should the Bucks be in the playoffs at that point.

The league could also play into August as a last resort to finish the season. Assuming the Tokyo Olympics remain on schedule (July 24-Aug. 9), that could affect which players are available for Team USA.

Regardless, the league will also look at date changes to the NBA combine, draft, free agency, Las Vegas Summer League and the 2020-21 schedule.

Another factor to consider: What if a player tests positive for coronavirus during the playoffs? What does the NBA do then? The league would use guidance from health experts, but that would throw another wrinkle into plans.

The CDC announcement is just a recommendation, not a government mandate. So the league could also resume sooner than eight weeks from now in a best-case scenario. Either way, in-arena attendance is expected to be at a minimum.

Should Silver pull the plug on the season? Other leagues have gone without a champion in a season – the NHL in 2005 and MLB in 1994. But those were related to labor issues.

There's no reason to make the decision now. It will depend on how bad the pandemic gets. It would be the first time in NBA history it went a year without a champion.

NBA SEASON AWARDS

LeBron, Morant, Nurse stood out this year

Nothing is more important than everyone's health and for the coronavirus outbreak to be contained. The NBA learned that the hard way when it continued play until Jazz center Rudy Gobert tested positive for COVID-19.

Since NBA teams have suspended games and all team practices, it would make sense that even if the CDC gives a more hopeful recommendation after two months, a resumption of games would still be a ways off.

Let's hope this virus is contained sooner. Should the NBA cancel the rest of its season, here are your regular-season award winners:

Regular-season MVP

LeBron James, Lakers: James maintained he did not care about this award just over a week ago. But he deserves what would be his fifth regular-season MVP honor.

I initially leaned toward voting for Milwaukee's Giannis Antetokounmpo because of how he has built on his 2018-19 MVP season and won the first head-to-head matchup against James this season. I changed my mind, though, af-

ter James outperformed Antetokounmpo in their second meeting 1½ weeks ago. Not only did James lead the Lakers to a win with his scoring and play making, he held Antetokounmpo to a combined 2 of 10 clip after defending him in the second half after Anthony Davis got in foul trouble.

I marveled at how James, 35, delayed Father Time in his 17th year after missing a combined 27 games last season because of a strained left groin, averaging 25.7 points per game and a league-leading 10.6 assists. But I also should have credited James more for his intangibles. He immediately empowered Davis, elevated his new supporting cast and supported coach Frank Vogel and his staff. James also helped bring the Lakers together after the death of NBA icon Kobe Bryant.

Rookie of the Year

Ja Morant, Grizzlies: Sorry, Zion Williamson. The Pelicans' star should not receive this award after missing the first 44 games because of his injured right knee. Sure, Williamson revitalized New Orleans' playoff chances by becoming the first rookie since Michael Jordan to have games of 20 points or more in 16 of his first 20 appearances.

But Morant has shown a larger body of work. Morant was on pace to become the fourth rookie guard in history to average at least 17 points per game while

shooting at least 47% from the field, a feat that only Jordan, Magic Johnson and Oscar Robertson accomplished. He also had posted at least 20 points and 10 assists in seven games, something only Johnson, Chris Paul, Luka Doncic and Trae Young did.

Defensive Player of the Year

Anthony Davis, Lakers: Davis had stated he wanted this award before the season started, and he has earned it in every way. According to NBA.com's tracking data, Davis held his opponents to a combined 38.5% from the field. He has ranked third in the NBA in blocks (2.4). And he has helped hold his teammates accountable on defense, including James a season after he was often disengaged on that end.

Sixth Man of the Year

Dennis Schroder, Thunder: Behind Paul's leadership and Shai Gilgeous-Alexander's quick development, Schroder is arguably the third-biggest reason why the Thunder have competed for a playoff spot instead of the draft lottery. Schroder has averaged a league-leading 19.1 points among reserves and has led his bench in scoring in 57 of 62 games. Since Nov. 25, Schroder was also part of a five-man closing lineup that helped the Thunder go 25-5 in games decided in crunchtime.

Coach of the Year

Nick Nurse, Raptors: A season after winning the NBA championship, Nurse has helped the Raptors remain a title contender despite the departures of Kawhi Leonard and Danny Green. It helped that the core roster remained. Nurse had to manage 15 different starting lineups to account for key injuries to Marc Gasol (out 27 games), Fred Van Vleet (15), Serge Ibaka (14) and Pascal Siakam (11). Despite those overlapping ailments, Toronto cemented a franchise-record 15-game winning streak from January to February.

Most Improved Player

Brandon Ingram, Pelicans: When he played for the Lakers in his first three NBA seasons, Ingram didn't become burdened with the expectations nor did he become consumed with the city's distractions. But Ingram should thank the Lakers they traded him to New Orleans as part of the Davis deal. Ingram wouldn't have had the right atmosphere needed to grow organically. He was on pace to cement career highs in points (24.3), 3-point shooting (38.7%), rebounds (6.3), assists (4.3) and minutes (34.8). After posting at least 17 points, five rebounds and five assists in a combined seven games through his first three NBA seasons, Ingram accomplished that feat 17 times this season.
