The following is adopted as the new CTC for the Contract effective December 29, 2022:



Contractor and Sourcewell hereby desire and agree to extend the Contract, with the above modification, for the period of December 29, 2022 through December 28, 2023.





Therefore, the Parties agree that the second paragraph of the Amendment shall be deleted in its entirety and replaced with the following:






