The following is adopted as the new CTC for the Contract effective September 12, 2023:

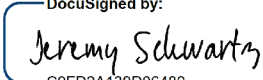

Contractor and Sourcewell hereby desire and agree to extend the Contract, with the above modification, for the period of September 12, 2023 through September 11, 2024.



The following is adopted as the new CTC for the Contract effective September 12, 2024:




