Bentley Flooring Solutions Installation Labor: Please refer to Labor pricing in the Contract. The contract installation rates and sundry item prices are only available through Bentley Flooring Solutions and must accompany a Bentley flooring installation purchase order. All pricing for labor is listed a not to exceed contract price. Local dealers may use this as a guide, but the local dealer installation rates, sundry items and procurement management fees may vary and are quoted as open market on a job by job basis.

Installation shall be performed by a Bentley Certified Installation Company in accordance with Bentley Mills, Inc. instructions and the Carpet and Rug Institute (CRI) Standards for Installation of Textile Floorcovering Materials (104 for Commercial/105 for Residential).

Installation prices are based on carpet installation in an open, empty office/dormitory /quarters space on a "clean floor." A "clean floor" is one where the condition is appropriate to accept carpet with no additional preparation other than possibly sweeping clean. Installation shall be performed anytime day or night Sunday - Saturday, with the exception of New York, Boston, and Chicago. Holidays are excluded.

Installation prices do not include adhesive.

Additional services can be provided by Bentley Mills, Inc. through its Certified dealer partners on an open market basis. Items such as carpet measurements, furnitur moving, and after hours work, etc. are available for quotation.

Use of low VOC (volatile organic compound) emitting, low odor adhesives which help alleviate indoor air pollution will be used for all installations.

Subfloor preparation (flash patching for uneven floor, extensive cleaning, cost of temporary warehousing, etc.) is not covered by this contract. Bentley Mills, Inc. is prepared to negotiate these and other services with the customer agency on an open market basis.

Compliance with all local laws, regulations and ordinances are the responsibility of Bentley Mills, Inc.

When installation is purchased, the contract price will be increased in states where the vendor must pay state or local tax on installed projects. Pertinent to F.A.R. Section 52.229-4, the vendor will charge for a reimbursement of taxes imposed on the contractor.

All installation projects may be subject to an administrative processing fee.

Take up carpet – Removal Disposal

Appropriate removal and disposal of existing flooring (recycling recommended) and floor preparation.

NOTE: Pricing is to include basic removal, disposal, and floor preparation; services above \$500 and work necessary to address potentially complex environmental problems, such as asbestos abatement, mold and mildew, or extensive floor preparation shall be negotiated with the customer on a case by case basis.

Furniture Lifting for Carpet Replacement

All furniture systems shall be lifted by equipment which has been structurally engineered for that particular furniture system. No crowbars or modified care jacks are to be used. Since work is being performed in occupied work area, "low VOC" or "no VOC" adhesives are to be used.
