

ASSIGNMENT AGREEMENT

Sourcewell Contracts: 010424-MES, 011124-MES, 011824-MES, 020124-MES, and 090122-MES

This Assignment Agreement is by and among **Sourcewell**, 202 12th Street Northeast, P.O. Box 219, Staples, MN 56479; **Municipal Emergency Services, LLC.**, formerly known as Municipal Emergency Services, Inc. (“MES”); and **MES Service Company** (“MES Service”).

Sourcewell awarded the following contracts to MES (“Contracts”):

The assignment provision of the Contract requires written consent of Sourcewell.

Assignment

1. This Assignment Agreement will become effective as of the date of the last signature below.
2. Sourcewell consents to the contract holder’s name change from Municipal Emergency Services, Inc., to Municipal Emergency Services, LLC.
3. MES wishes to assign to MES Service all of MES’s rights, responsibilities, and other provisions set forth in the following contracts, Sourcewell Contract Numbers: **010424-MES, 011124-MES, 011824-MES, 020124-MES, and 090122-MES.**
4. MES Service has obtained a copy of each of the Contracts from MES and certifies it will comply with the terms of the Contract as executed by MES and Sourcewell. The parties agree this Assignment is unconditional and without recourse.
5. MES and MES Service jointly and severally represent and warrant to Sourcewell that:
 - a. MES is not in default of any of its obligations under any of the Contracts;
 - b. MES Service is ready, willing, and able to perform all of the obligations and responsibilities of each the Contracts;
