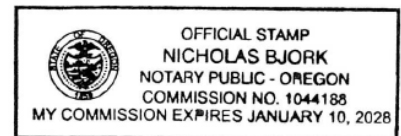



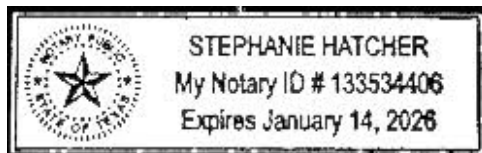

# American golf teams' fashion threads not a hole-in-one but will stand out

PARIS – Nobody at the Paris Olympics is going to stand out more, at least from a sartorial standpoint, than the men and women on the U.S. golf team.

Let's call it a Scandinavian spin on the stars and stripes. American strength meets Swedish form and function. A wow factor worthy of both Stockholm and Shinnecock.

If you regularly watch the PGA Tour, you're probably already familiar with J. Lindeberg, the Swedish clothing company that outfits world No. 7 Viktor Hovland in distinctive designs and colors that often border on the outrageous. Now, J. Lindeberg is making its next move in the sportswear space, partnering with USA Golf for the 2024 and 2028 Olympics.

You may love the uniforms that will be worn this week by Scottie Scheffler, Xander Schauffele, Nelly Korda and the rest of the Americans competing at Le Golf National just outside Paris. You may hate them. But you're definitely going to notice – and that's very much, pardon the pun, by design.

J. Lindeberg's distinctly Scandinavian style isn't for everyone. Week-to-week on the PGA Tour, for instance, Hovland's outfits are almost as likely to be mocked on social media as they are praised. But they're always noticed.

And for a niche brand that has been around since the late 1990s but is starting to gain a serious foothold in the American market, the opportunity to outfit golfers at the Olympics is a whole new level of visibility that might inspire, could possibly enrage and will almost assuredly sell a whole lot of product that you'll be seeing at your local golf club.

But why J. Lindeberg? In a sportswear industry with so many American companies, how did a Swedish brand end up getting the Team USA contract for a traditional, perhaps even staid sport like golf?

Well, there was a bidding process, of course. But within that competition, according to PGA Tour and USA Golf executive Andy Levinson, was a desire to give American golfers a bold and distinctive look that would emphasize the fact that they're athletes when they're walking around the Olympic Village rubbing elbows with other athletes.

"I want as many people not being happy with what we're doing as being happy with what we're doing," Scott Davis, the CEO and brand director for J. Lindeberg North America, told USA

TODAY Sports. "It creates this 360 effect. If no one's talking about you, that's a lot worse. Right?"

"There's a perception of golf being on that border between serious athlete versus, you know, some type of recreational activity," Levinson said. "And if you look at today's golfers, they're real athletes. All of these guys could probably, and probably did, at some point in their lives compete in other sports. And so when we're at the Olympic Games and surrounded by this fabulous mix of athletes from all these different disciplines, it was very important to us that we have a partner that is going to outfit our players in a manner that makes them feel athletic all the time and as emboldened as they possibly can be."

With J. Lindeberg's mix of European cuts, sharp-angled stripes and clean geometric patterns that has turned the American flag into modern art, it's fair to say American golfers have already won the gold medal for style.

And even if the uniforms are a bit controversial for fans who prefer a more toward traditional look, that's OK. Pushing boundaries is part of the strategy.

"We always want to be sophisticated first, and disruptive second," Davis said. "That's how we see our brand. It's absolutely born and sits in that Scandinavian lifestyle field. So we want the consumer to feel cleanliness, fit, technicality, plus a little bit of disruption."

And it's working.

Though J. Lindeberg made a bit of a golf splash in the company's infancy with fashion plate Jesper Parnevik – yes, they were responsible for his iconic vest-and-tie outfit – the company's visibility kind of faded a bit after he left the tour.

That all changed when Davis signed Hovland to an apparel deal in 2019.

A Norwegian who played college golf at Oklahoma State, Davis had a conviction that Hovland might be the next big thing in the sport – and not just because of his talent but because he had a personality that would translate well to an American audience.

Hovland quickly established himself as an elite player after turning pro, which meant he was on television a lot – which also meant his distinctive clothing was being seen by millions of people on a regular basis. And whether it was the famous Azalea shirt he wore at the Masters or hot pink trousers or blue tiger stripes at last year's U.S. Open, fans notice and talk about it online.

According to Davis, that has translated to a discernible uptick in J. Lindeberg's business – even though he admits that not everybody is going to want to dress like Hovland.

"It's been transformational," he said. "And it was lucky."

Now, the company's profile is expanding. It has signed athletes in other sports such as Chris Eubanks and 2023 Wimbledon champion Marketa Vondrousova in tennis. Pickleball is a potential area of growth. But the Olympics is going to put the brand on a stage like never before – and depict American golfers in a way nobody has seen.

"For us to have our product on the best players from the United States for 250 hours and TV coverage, or whatever it is with the bridge on the right chest, and that Old Glory on the back yolk and USA on the left chest as an American and military brat, it was something that I had to bring to the finish line," Davis said. "And from a brand perspective, it's a huge elevation for us."

# Rahm supports changing selection process

Spain's Jon Rahm would like to see a different format and different way of selecting the golfers to participate in the Olympics.

Speaking ahead of Thursday's first round of the men's tournament at the Paris Games, Rahm proposed allowing each country to select its representing golfers, as opposed to the current format based on world golf rankings.

"There needs to be some guidelines," Rahm told reporters at Le Golf National, "but, like, Team USA Basketball (is) free to choose whoever they want."

The Olympic qualifying process has come under scrutiny this year for excluding some players for LIV Golf, whose three-round tournaments aren't acknowledged by the world rankings.

While seven LIV players, including Rahm, were able to qualify for their country, Americans like reigning U.S. Open champ Bryson DeChambeau and Brooks Koepka of the USA were not.

"I think you need to let each country choose who they want to play," Rahm said.

Golf is still a relatively new inclusion for the Olympics, having only rejoined the program in 2016 after a 112-year absence. In doing so, it has adopted a traditional 72-hole individual tournament.

Rahm said he'd like the Olympics to expand to include "some team aspect."

"That would be extremely nice to share the stage with another player," Rahm said, "to do something different, to maybe what we do every other day."

Team USA's Xander Schauffele, also speaking to reporters Tuesday, pushed back a bit on the idea of a team event in addition to the individual tournament, because it would mean more golf for a tour accustomed to regularly playing from Thursday to Sunday, as will be the case this week.

"I'm a big advocate of don't knock on it until you try it," Schauffele said. "My only issue with it would be sort of the run of events, it being two weeks in a row. ... It would be sticky to do two tournaments in a row, and because of that, you may lose some guys."

# Kelce's appearance 'super cool' for field hockey

PARIS – There's a popular trend taking place at the Paris Olympics for Team USA athletes participating in sports that don't often get the limelight.

Celebrity spectators. Snoop Dogg is making the rounds at several Olympic events. He even had a hilarious play-by-play call during a Team USA badminton match. Flavor Flav has become Team USA's women's water polo hype man.

For U.S. women's field hockey, it's former Philadelphia Eagles center Jason Kelce.

Kelce has more free time on his hands these days. He retired from the NFL in March. He's spending the first summer of his retirement in style. Kelce and his

wife, Kylie, are in Paris taking in some Olympic action.

"We love sports. We love competition. We love world events. This is such a unique place where the entire world comes together and bonds over competition and sports," Jason said. "I've never been able to participate in one (an Olympic Games) because of football, because I'm either in training camp or in the middle of the season. So, when we found out that we were gonna have an opportunity to go to this, the more we thought about it, we were like, 'Let's take advantage of it now.'"

Kylie is a former collegiate field hockey athlete at Cabrini University, so it's only fitting the Kelces went to support

the U.S. women's field hockey club.

The Kelce's watched Team USA take on 2020 silver medalist Argentina in its Olympic opener, and Jason Kelce was ready for the occasion.

"We're in France, in Paris, and I love assimilating to different cultures and whatnot. I know this is about as stereotypical as you can get. ... I've already had a bunch of croissants and baguettes too, I just didn't carry them with me to the game," Jason said. "I'm definitely taking in the full experience."

The U.S. women lost 4-1, but Kelce enjoyed watching the team compete against one of the best field hockey teams in the world.

"They played hard, they're a young team, and they played arguably the best team in the world. They had their moments. They played them hard. And the

score, in my opinion, doesn't reflect how close it was for a lot of it. Argentina just did a really good job of capitalizing their opportunities. And their goalie, I mean, oh my gosh, diving and saving all over the place," Jason said. "It was a fun game to watch, and I'm proud of the girls."

The field hockey team also met with the former Eagles center. Coincidentally, nine of the 16 players on the U.S. team are from Pennsylvania. The Keystone State ties was one thing for U.S. field hockey player Sophia Gladieux, but Jason's connection with Taylor Swift, who is also a Pennsylvania native, is what really excited her. Jason's brother, Travis, famously dates the singer.

"The fact that I hugged Jason Kelce, who has probably hugged Taylor Swift, is keeping me up at night," Gladieux said. "It's super cool. And I love it."

# Wrestling's 'young GOAT' Amit Elor golden

MANHEIM, Pa. – It is not normal, the way that people in the women's wrestling community talk about Amit Elor, who won gold at the Paris Olympics. The 20-year-old is often described as a prodigy, sure. A wunderkind. A phenomenon. But in some corners of the sport, her ascent is talked about almost like it's a rare meteorological event – a 50-year comet, flashing across the sky.

Terry Steiner, the head coach of the U.S. women's wrestling team since 2002, calls her "a generational talent" and doesn't think Team USA has ever had anyone like her, at least not since he's been around. Iowa women's wrestling coach Clarissa Chun describes her as "a young GOAT" who is destined for the Hall of Fame. "I believe that," Chun said. "As long as she stays healthy."

Their reasons for optimism are clear. In each of the past two seasons, Elor has won under-20, under-23 and senior world championships, dominating opponents at each of the three age divisions she is eligible to enter. She has not lost an international match since 2019. And in the 37 matches since that loss, according to United World Wrestling statistics, she has outscored her opponents by a margin of 322-16.

"We don't come around these athletes very often," Steiner said. "She's special."

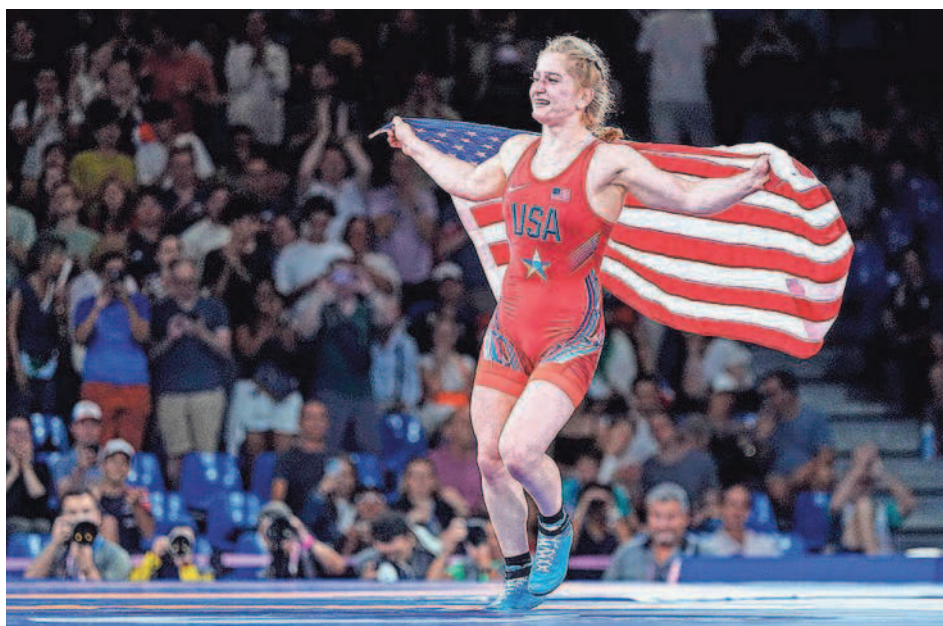
Even if she might not always feel that way. "Sometimes I'm like, 'Why is everybody so interested in me?'" said Elor, who became the youngest U.S. wrestler to win an Olympic gold medal. "I don't know. I just feel after everything I've been through, I don't feel any different."

Just because Elor has been successful on the mat doesn't mean her journey has been an easy one. In 2018, she mourned the death of her older brother Oshry, killed at his house during an attempted robbery. Then in 2022, her father, Yair, died suddenly under heart-wrenching circumstances in the wake of the COVID-19 pandemic.

Monday, her first day of competition in these Games, would have been his 67th birthday. "It just happened to be that way," Elor said. "And I really hope that I can make the finals for him."

## Start in wrestling

Elor started wrestling when she was

4½, hooked by a sport that her mother, Elana, would have preferred she avoid.

The youngest of six kids, Elor remembers tagging along to her older brother Orry's wrestling practices in the Bay Area and being immediately entranced. She begged and begged and begged her mother to let her give the sport a try. Eventually, Elana Elor relented, but under one condition. She told her daughter the wrestling club didn't have a program for kids her age, but she could have a one-on-one conversation with the head coach – who was "very intimidating," Elana said – and ask him for a chance.

Months before her fifth birthday, Elor went to the coach's office. He obliged.

Elor said she wasn't an especially confrontational or physical kid, though strength runs in her family. Her brothers played high school football or wrestled, each an imposing figure with a large frame, like their father. Yair Elor immigrated from Israel to throw shut out for the track and field team at Boise State.

Wrestling as a child meant that, until she was 10, Amit competed only against boys. She recalls sometimes feeling isolated and unwanted. Boys would complain about having to wrestle her or make excuses about why they couldn't. In other cases, she said, they would get angry and almost take it out on her, getting unnecessarily physical and causing minor injuries on the mat.

Elor's mother, meanwhile, recalled driving around to different wrestling groups in the Bay Area, trying to find coaches who wouldn't treat Amit differently. "When she started, they were OK, it was like, 'Oh, there's a girl among the boys,'" Elana Elor said. "But once she started beating up the boys, there were a lot of coaches that didn't like it. They would tell her, 'Go easy on the boys.'"

Elor's nomadic wrestling childhood exposed her to a wide variety of coaching styles, her mother said. She also spent several summers in Israel, where she was exposed to international techniques and training methods, and took up judo and jujitsu at different points.

During one particularly intensive stretch, Elor said she was maintaining a regular wrestling training schedule while also incorporating separate jujitsu sessions, every day: "I was basically training all day long. It was wonderful."

It was around that time that Elor started to view the Olympics as a realistic opportunity.

Orry, who is 11 years older than Amit, had come close to making it to the Games. In 2016, he placed fourth at the U.S. Olympic trials in Greco-Roman wrestling. A few years later, after Amit won an under-15 Pan American title in Mexico, it became clear that she would also get her shot.

"I think people will look at her physically and say she's a specimen – so

strong for her age – and that's part of it," said Steiner, the U.S. women's wrestling coach. "But technically, she's very, very sound. Very hard to score on. ... She just does a lot of things well."

## Mental toughness

Elor said she's "never truly felt my age," which may be part of the reason why she won her first under-20 world title when she was just 17 and her first senior world championship at 18.

Elana Elor said there's also a mental toughness that has enabled her daughter to compartmentalize and continue competing through periods of tragedy and grief – including the deaths of two people who were closest to her.

Elor's mother said they were at a wrestling tournament in 2018 when they received a phone call that Amit's older brother Oshry had been shot in what police later described as a marijuana-related robbery attempt, in which a group of men purchasing marijuana from Oshry later attacked and shot him.

Then, about two years later, Elor was confronted with tragedy again with the sudden death of her father. Although some of the details remain unclear, even among members of the family, Amit's brother Orry said their father had isolated himself at the start of the COVID-19 pandemic due to a fear of catching the disease. He added that the family believes he had fallen victim to misinformation and conspiracy theories.

Amit said her father's death was difficult for her to process in part because of how much he had supported her throughout her wrestling career and the fact that he was gone by the time it took off. Yair Elor died in April 2022, and she won her first senior world title five months later.

"It was really hard to continue after that and just be OK, mentally," she said. "I think just knowing how much he believed in me and how much he supported me is what led me to continue and power through. Because I just wanted to make him proud."

In a sport where anything can happen, she said she often surprises herself with her own performances. At her first world championships, for instance she recalled being "shocked" every time the official raised her hand.

"I hope I can shock myself at the Olympics, too," she said before the Games.

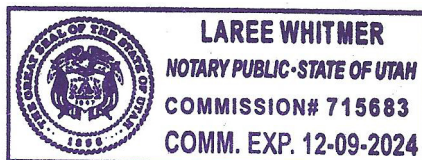
