All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

ADB Safegate Americas, LLC, has been serving airports for over 100 years. They offer a full line of airport lighting equipment, and services. Their sales staff will work throughout the United States to serve Sourcewell participating entities. Their multiple warehouses allow them to quickly serve entities across the United States and Canada. They are offering substantial discounts off list price.

Axtell's, Inc., can provide a full complement of airport runway services. Axtell's sales and service teams are ready to serve all Sourcewell participating entities in the United States. Axtell's is a certified woman-owned small business. They are offering Sourcewell participating entities solid discounts from list pricing.

Hi-Lite Airfield Services, LLC, has offered airport runway painting and maintenance for over 30 years. They will work throughout the United States and Canada to serve Sourcewell participating entities. They offer an extensive handstriper/marking layout training program to Sourcewell entities. They are offering substantial discounts off list price.

Nachurs Alpine Solutions, has a 75 year history of providing runway deicers. Nachurs' sales and service teams along with their production facilities and warehouses are ready to serve Sourcewell participating entities in the United States and Canada.
