Expired chemicals should be properly disposed of and replaced if needed.

(Moderate) Right- The distance between the wheel periphery and the adjustable tongue or the end of the peripheral member at the top shall never exceed one-fourth inch.

OSHA 1910.215(b)(9)
Work rests shall be kept adjusted closely to the wheel with a maximum opening of one-eighth inch to prevent the work from being jammed between

the wheel and the rest OSHA 1910.215(a)(4)


