



**MASTER AGREEMENT #030425**  
**CATEGORY: Public Safety Software**  
**SUPPLIER: VIDIZMO LLC**

This Master Agreement (Agreement) is between Sourcewell, a Minnesota service cooperative located at 202 12th Street Northeast, P.O. Box 219, Staples, MN 56479 (Sourcewell) and VIDIZMO LLC, 1775 Tysons Blvd, Tysons, VA 22102 (Supplier).

Sourcewell is a local government and service cooperative created under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) offering a Cooperative Purchasing Program to eligible participating government entities.

Under this Master Agreement entered with Sourcewell, Supplier will provide Included Solutions to Participating Entities through Sourcewell's Cooperative Purchasing Program.

**Article 1:**  
**General Terms**

The General Terms in this Article 1 control the operation of this Master Agreement between Sourcewell and Supplier and apply to all transactions entered by Supplier and Participating Entities. Subsequent Articles to this Master Agreement control the rights and obligations directly between Sourcewell and Supplier (Article 2), and between Supplier and Participating Entity (Article 3), respectively. These Article 1 General Terms control over any conflicting terms. Where this Master Agreement is silent on any subject, Participating Entity and Supplier retain the ability to negotiate mutually acceptable terms.

- 1) **Purpose.** Pursuant to Minnesota law, the Sourcewell Board of Directors has authorized a Cooperative Purchasing Program designed to provide Participating Entities with access to competitively awarded cooperative purchasing agreements. To facilitate the Program, Sourcewell has awarded Supplier this cooperative purchasing Master Agreement following a competitive procurement process intended to meet compliance standards in accordance with Minnesota law and the requirements contained herein.
- 2) **Intent.** The intent of this Master Agreement is to define the roles of Sourcewell, Supplier, and Participating Entity as it relates to Sourcewell's Cooperative Purchasing Program.
- 3) **Participating Entity Access.** Sourcewell's Cooperative Purchasing Program Master Agreements are available to eligible public agencies (Participating Entities). A Participating Entity's authority to access Sourcewell's Cooperative Purchasing Program is determined through the laws of its respective jurisdiction.
- 4) **Supplier Access.** The Included Solutions offered under this Agreement may be made available to any Participating Entity. Supplier understands that a Participating Entity's use of this Agreement is at the Participating Entity's sole convenience. Supplier will educate its sales and service forces about

Sourcewell eligibility requirements and required documentation. Supplier will be responsible for ensuring sales are with Participating Entities.

- 5) **Term.** This Agreement is effective upon the date of the final signature below. The term of this Agreement is four (4) years from the effective date. The Agreement expires at 11:59 P.M. Central Time on July 17, 2029, unless it is cancelled or extended as defined in this Agreement.
- a) **Extensions.** Sourcewell and Supplier may agree to up to three (3) additional one-year extensions beyond the original four-year term. The total possible length of this Agreement will be seven (7) years from the effective date.
- b) **Exceptional Circumstances.** Sourcewell retains the right to consider additional extensions as required under exceptional circumstances.
- 6) **Survival of Terms.** Notwithstanding the termination of this Agreement, the obligations of this Agreement will continue through the performance period of any transaction entered between Supplier and any Participating Entity before the termination date.
- 7) **Scope.** Supplier is awarded a Master Agreement to provide the solutions identified in Solicitation #030425, Category 2. Public Safety Response – Agency Operations, to Participating Entities. In-scope solutions include:
- a) Category 2. Public Safety Response – Agency Operations, including but not limited to:
- i) Pre-incident planning software, such as:
    - (1) Fire prevention related inspections and enforcement;
    - (2) Operational management (scheduling, training, compliance, etc.); and
    - (3) Data analytics to inform staffing, deployment, station location, budget, and other management decisions.
  - ii) Incident/post-incident software, such as:
    - (1) CAD, RMS for law enforcement, fire, and EMS;
    - (2) Electronic Patient Care Reporting (ePCR) and data transfer to hospitals;
    - (3) Digital and physical evidence management;
    - (4) E-citation systems; and
    - (5) Law enforcement case management

Complimentary equipment, accessories, and services must be directly related to the offering of systems or solutions described in section 7)a) above. Software platforms or solutions should be able to integrate with a broad range of other software and hardware solutions to improve and/or expand agency capabilities. Sourcewell IS NOT looking for artificial intelligence (AI) customization, but public safety software with existing AI capabilities is eligible.

- 8) **Included Solutions.** Supplier's Proposal to the above referenced RFP is incorporated into this Master Agreement. Only those Solutions included within Supplier's Proposal and within Scope (Included Solutions) are included within the Agreement and may be offered to Participating Entities.
- 9) **Indefinite Quantity.** This Master Agreement defines an indefinite quantity of sales to eligible Participating Entities.

- 10) **Pricing.** Pricing information (including Pricing and Delivery and Pricing Offered tables) for all Included Solutions within Supplier's Proposal is incorporated into this Master Agreement.
- 11) **Not to Exceed Pricing.** Suppliers may not exceed the prices listed in the current Pricing List on file with Sourcwell when offering Included Solutions to Participating Entities. Participating Entities may request adjustments to pricing directly from Supplier during the negotiation and execution of any transaction.
- 12) **Open Market.** Supplier's open market pricing process is included within its Proposal.
- 13) Supplier Representations:**
- i) **Compliance.** Supplier represents and warrants it will provide all Included Solutions under this Agreement in full compliance with applicable federal, state, and local laws and regulations.
  - ii) **Licenses.** As applicable, Supplier will maintain a valid status on all required federal, state, and local licenses, bonds, and permits required for the operation of Supplier's business with Participating Entities. Participating Entities may request all relevant documentation directly from Supplier.
  - iii) **Supplier Warrants.** Supplier warrants that all Included Solutions furnished under this Agreement are free from liens and encumbrances, and are free from defects in design, materials, and workmanship. In addition, Supplier warrants the Solutions are suitable for and will perform in accordance with the ordinary use for which they are intended.
- 14) **Bankruptcy Notices.** Supplier certifies and warrants it is not currently in a bankruptcy proceeding. Supplier has disclosed all current and completed bankruptcy proceedings within the past seven years within its Proposal. Supplier must provide notice in writing to Sourcwell if it enters a bankruptcy proceeding at any time during the term of this Agreement.
- 15) **Debarment and Suspension.** Supplier certifies and warrants that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from programs operated by the State of Minnesota, the United States federal government, or any Participating Entity. Supplier certifies and warrants that neither it nor its principals have been convicted of a criminal offense related to the subject matter of this Agreement. Supplier further warrants that it will provide immediate written notice to Sourcwell if this certification changes at any time during the term of this Agreement.
- 16) **Provisions for non-United States federal entity procurements under United States federal awards or other awards (Appendix II to 2 C.F.R § 200).** Participating Entities that use United States federal grant or other federal funding to purchase solutions from this Agreement may be subject to additional requirements including the procurement standards of the Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards, 2 C.F.R. § 200. Participating Entities may have additional requirements based on specific funding source terms or conditions. Within this Section, all references to "federal" should be interpreted to mean the United States federal government. The following list applies when a Participating Entity accesses Supplier's Included Solutions with United States federal funds.

i) **EQUAL EMPLOYMENT OPPORTUNITY.** Except as otherwise provided under 41 C.F.R. § 60, all agreements that meet the definition of “federally assisted construction contract” in 41 C.F.R. § 60-1.3 must include the equal opportunity clause provided under 41 C.F.R. § 60-1.4(b), in accordance with Executive Order 11246, “Equal Employment Opportunity” (30 FR 12319, 12935, 3 C.F.R. §, 1964-1965 Comp., p. 339), as amended by Executive Order 11375, “Amending Executive Order 11246 Relating to Equal Employment Opportunity,” and implementing regulations at 41 C.F.R. § 60, “Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor.” The equal opportunity clause is incorporated herein by reference.

ii) **DAVIS-BACON ACT, AS AMENDED (40 U.S.C. § 3141-3148).** When required by federal program legislation, all prime construction contracts in excess of \$2,000 awarded by non-federal entities must include a provision for compliance with the Davis-Bacon Act (40 U.S.C. § 3141-3144, and 3146-3148) as supplemented by Department of Labor regulations (29 C.F.R. § 5, “Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction”). In accordance with the statute, contractors must be required to pay wages to laborers and mechanics at a rate not less than the prevailing wages specified in a wage determination made by the Secretary of Labor. In addition, contractors must be required to pay wages not less than once a week. The non-federal entity must place a copy of the current prevailing wage determination issued by the Department of Labor in each solicitation. The decision to award a contract or subcontract must be conditioned upon the acceptance of the wage determination. The non-federal entity must report all suspected or reported violations to the federal awarding agency. The contracts must also include a provision for compliance with the Copeland “Anti-Kickback” Act (40 U.S.C. § 3145), as supplemented by Department of Labor regulations (29 C.F.R. § 3, “Contractors and Subcontractors on Public Building or Public Work Financed in Whole or in Part by Loans or Grants from the United States”). The Act provides that each contractor or subrecipient must be prohibited from inducing, by any means, any person employed in the construction, completion, or repair of public work, to give up any part of the compensation to which he or she is otherwise entitled. The non-federal entity must report all suspected or reported violations to the federal awarding agency. Supplier must comply with all applicable Davis-Bacon Act provisions.

iii) **CONTRACT WORK HOURS AND SAFETY STANDARDS ACT (40 U.S.C. § 3701-3708).** Where applicable, all contracts awarded by the non-federal entity in excess of \$100,000 that involve the employment of mechanics or laborers must include a provision for compliance with 40 U.S.C. §§ 3702 and 3704, as supplemented by Department of Labor regulations (29 C.F.R. § 5). Under 40 U.S.C. § 3702 of the Act, each contractor must be required to compute the wages of every mechanic and laborer on the basis of a standard work week of 40 hours. Work in excess of the standard work week is permissible provided that the worker is compensated at a rate of not less than one and a half times the basic rate of pay for all hours worked in excess of 40 hours in the work week. The requirements of 40 U.S.C. § 3704 are applicable to construction work and provide that no laborer or mechanic must be required to work in surroundings or under working conditions which are unsanitary, hazardous or dangerous. These requirements do not apply to the purchases of supplies, materials, or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence. This provision is hereby incorporated by reference into this Agreement. Supplier certifies that during the term of an award for all Agreements by Sourcewell resulting from this procurement process, Supplier must comply with applicable requirements as referenced above.

iv) **RIGHTS TO INVENTIONS MADE UNDER A CONTRACT OR AGREEMENT.** If the federal award meets the definition of “funding agreement” under 37 C.F.R. § 401.2(a) and the recipient or subrecipient wishes to enter into a contract with a small business firm or nonprofit organization regarding the substitution of parties, assignment or performance of experimental, developmental, or research work under that “funding agreement,” the recipient or subrecipient must comply with the requirements of 37 C.F.R. § 401, “Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements,” and any implementing regulations issued by the awarding agency. Supplier certifies that during the term of an award for all Agreements by Sourcewell resulting from this procurement process, Supplier must comply with applicable requirements as referenced above.

v) **CLEAN AIR ACT (42 U.S.C. § 7401-7671Q.) AND THE FEDERAL WATER POLLUTION CONTROL ACT (33 U.S.C. § 1251-1387).** Contracts and subgrants of amounts in excess of \$150,000 require the non-federal award to agree to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act (42 U.S.C. § 7401- 7671q) and the Federal Water Pollution Control Act as amended (33 U.S.C. § 1251- 1387). Violations must be reported to the Federal awarding agency and the Regional Office of the Environmental Protection Agency (EPA). Supplier certifies that during the term of this Agreement it will comply with applicable requirements as referenced above.

vi) **DEBARMENT AND SUSPENSION (EXECUTIVE ORDERS 12549 AND 12689).** A contract award (see 2 C.F.R. § 180.220) must not be made to parties listed on the government wide exclusions in the System for Award Management (SAM), in accordance with the OMB guidelines at 2 C.F.R. § 180 that implement Executive Orders 12549 (3 C.F.R. § 1986 Comp., p. 189) and 12689 (3 C.F.R. § 1989 Comp., p. 235), “Debarment and Suspension.” SAM Exclusions contains the names of parties debarred, suspended, or otherwise excluded by agencies, as well as parties declared ineligible under statutory or regulatory authority other than Executive Order 12549. Supplier certifies that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation by any federal department or agency.

vii) **BYRD ANTI-LOBBYING AMENDMENT, AS AMENDED (31 U.S.C. § 1352).** Suppliers must file any required certifications. Suppliers must not have used federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any federal contract, grant, or any other award covered by 31 U.S.C. § 1352. Suppliers must disclose any lobbying with non-federal funds that takes place in connection with obtaining any federal award. Such disclosures are forwarded from tier to tier up to the non-federal award. Suppliers must file all certifications and disclosures required by, and otherwise comply with, the Byrd Anti-Lobbying Amendment (31 U.S.C. § 1352).

viii) **RECORD RETENTION REQUIREMENTS.** To the extent applicable, Supplier must comply with the record retention requirements detailed in 2 C.F.R. § 200.333. The Supplier further certifies that it will retain all records as required by 2 C.F.R. § 200.333 for a period of 3 years after grantees or subgrantees submit final expenditure reports or quarterly or annual financial reports, as applicable, and all other pending matters are closed.

- ix) **ENERGY POLICY AND CONSERVATION ACT COMPLIANCE.** To the extent applicable, Supplier must comply with the mandatory standards and policies relating to energy efficiency which are contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act.
- x) **BUY AMERICAN PROVISIONS COMPLIANCE.** To the extent applicable, Supplier must comply with all applicable provisions of the Buy American Act. Purchases made in accordance with the Buy American Act must follow the applicable procurement rules calling for free and open competition.
- xi) **ACCESS TO RECORDS (2 C.F.R. § 200.336).** Supplier agrees that duly authorized representatives of a federal agency must have access to any books, documents, papers and records of Supplier that are directly pertinent to Supplier's discharge of its obligations under this Agreement for the purpose of making audits, examinations, excerpts, and transcriptions. The right also includes timely and reasonable access to Supplier's personnel for the purpose of interview and discussion relating to such documents.
- xii) **PROCUREMENT OF RECOVERED MATERIALS (2 C.F.R. § 200.322).** A non-federal entity that is a state agency or agency of a political subdivision of a state and its contractors must comply with Section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. § 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition, where the purchase price of the item exceeds \$10,000 or the value of the quantity acquired during the preceding fiscal year exceeded \$10,000; procuring solid waste management services in a manner that maximizes energy and resource recovery; and establishing an affirmative procurement program for procurement of recovered materials identified in the EPA guidelines.
- xiii) **FEDERAL SEAL(S), LOGOS, AND FLAGS.** The Supplier cannot use the seal(s), logos, crests, or reproductions of flags or likenesses of Federal agency officials without specific pre-approval.
- xiv) **NO OBLIGATION BY FEDERAL GOVERNMENT.** The U.S. federal government is not a party to this Agreement or any purchase by a Participating Entity and is not subject to any obligations or liabilities to the Participating Entity, Supplier, or any other party pertaining to any matter resulting from the Agreement or any purchase by an authorized user.
- xv) **PROGRAM FRAUD AND FALSE OR FRAUDULENT STATEMENTS OR RELATED ACTS.** The Contractor acknowledges that 31 U.S.C. § 38 (Administrative Remedies for False Claims and Statements) applies to the Supplier's actions pertaining to this Agreement or any purchase by a Participating Entity.
- xvi) **FEDERAL DEBT.** The Supplier certifies that it is non-delinquent in its repayment of any federal debt. Examples of relevant debt include delinquent payroll and other taxes, audit disallowance, and benefit overpayments.
- xvii) **CONFLICTS OF INTEREST.** The Supplier must notify the U.S. Office of General Services, Sourcewell, and Participating Entity as soon as possible if this Agreement or any aspect related



to the anticipated work under this Agreement raises an actual or potential conflict of interest (as described in 2 C.F.R. Part 200). The Supplier must explain the actual or potential conflict in writing in sufficient detail so that the U.S. Office of General Services, Sourcewell, and Participating Entity are able to assess the actual or potential conflict; and provide any additional information as necessary or requested.

xviii) **U.S. EXECUTIVE ORDER 13224.** The Supplier, and its subcontractors, must comply with U.S. Executive Order 13224 and U.S. Laws that prohibit transactions with and provision of resources and support to individuals and organizations associated with terrorism.

xix) **PROHIBITION ON CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT.** To the extent applicable, Supplier certifies that during the term of this Agreement it will comply with applicable requirements of 2 C.F.R. § 200.216.

xx) **DOMESTIC PREFERENCES FOR PROCUREMENTS.** To the extent applicable, Supplier certifies that during the term of this Agreement, Supplier will comply with applicable requirements of 2 C.F.R. § 200.322.

## **Article 2: Sourcewell and Supplier Obligations**

The Terms in this Article 2 relate specifically to Sourcewell and its administration of this Master Agreement with Supplier and Supplier's obligations thereunder.

- 1) **Authorized Sellers.** Supplier must provide Sourcewell a current means to validate or authenticate Supplier's authorized dealers, distributors, or resellers which may complete transactions of Included Solutions offered under this Agreement. Sourcewell may request updated information in its discretion, and Supplier agrees to provide requested information within a reasonable time.
- 2) **Product and Price Changes Requirements.** Supplier may request Included Solutions changes, additions, or deletions at any time. All requests must be made in writing by submitting a Sourcewell Price and Product Change Request Form to Sourcewell. At a minimum, the request must:
  - Identify the applicable Sourcewell Agreement number;
  - Clearly specify the requested change;
  - Provide sufficient detail to justify the requested change;
  - Individually list all Included Solutions affected by the requested change, along with the requested change (e.g., addition, deletion, price change); and
  - Include a complete restatement of Pricing List with the effective date of the modified pricing, or product addition or deletion. The new pricing restatement must include all Included Solutions offered, even for those items where pricing remains unchanged.

A fully executed Sourcewell Price and Product Change Request Form will become an amendment to this Agreement and will be incorporated by reference.

- 3) **Authorized Representative.** Supplier will assign an Authorized Representative to Sourcewell for this Agreement and must provide prompt notice to Sourcewell if that person is changed. The Authorized Representative will be responsible for:
  - Maintenance and management of this Agreement;
  - Timely response to all Sourcewell and Participating Entity inquiries; and
  - Participation in reviews with Sourcewell.

Sourcewell's Authorized Representative is its Chief Procurement Officer.

- 4) **Performance Reviews.** Supplier will perform a minimum of one review with Sourcewell per agreement year. The review will cover transactions to Participating Entities, pricing and terms, administrative fees, sales data reports, performance issues, supply chain issues, customer issues, and any other necessary information.
- 5) **Sales Reporting Required.** Supplier is required as a material element to this Master Agreement to report all completed transactions with Participating Entities utilizing this Agreement. Failure to provide complete and accurate reports as defined herein will be a material breach of the Agreement and Sourcewell reserves the right to pursue all remedies available at law including cancellation of this Agreement.



- 6) **Reporting Requirements.** Supplier must provide Sourcewell an activity report of all transactions completed utilizing this Agreement. Reports are due at least once each calendar quarter (Reporting Period). Reports must be received no later than 45 calendar days after the end of each calendar quarter. Supplier may report on a more frequent basis in its discretion. Reports must be provided regardless of the amount of completed transactions during that quarter (i.e., if there are no sales, Supplier must submit a report indicating no sales were made).

The Report must contain the following fields:

- Participating Entity Name (e.g., City of Staples Highway Department);
- Participating Entity Physical Street Address;
- Participating Entity City;
- Participating Entity State/Province;
- Participating Entity Zip/Postal Code;
- Sourcewell Participating Entity Account Number;
- Transaction Description;
- Transaction Purchased Price;
- Sourcewell Administrative Fee Applied; and
- Date Transaction was invoiced/sale was recognized as revenue by Supplier.

If collected by Supplier, the Report may include the following fields as available:

- Participating Entity Contact Name;
- Participating Entity Contact Email Address;
- Participating Entity Contact Telephone Number;

- 7) **Administrative Fee.** In consideration for the support and services provided by Sourcewell, Supplier will pay an Administrative Fee to Sourcewell on all completed transactions to Participating Entities utilizing this Agreement. Supplier will include its Administrative Fee within its proposed pricing. Supplier may not directly charge Participating Entities to offset the Administrative Fee.
- 8) **Fee Calculation.** Supplier's Administrative Fee payable to Sourcewell will be calculated as a stated percentage (listed in Supplier's Proposal) of all completed transactions utilizing this Master Agreement within the preceding Reporting Period. For certain categories, a flat fee may be proposed. The Administrative Fee will be stated in Supplier's Proposal.
- 9) **Fee Remittance.** Supplier will remit fee to Sourcewell no later than 45 calendar days after the close of the preceding calendar quarter in conjunction with Supplier's Reporting Period obligations defined herein. Payments should note the Supplier's name and Sourcewell-assigned Agreement number in the memo; and must be either mailed to Sourcewell above "Attn: Accounts Receivable" or remitted electronically to Sourcewell's banking institution per Sourcewell's Finance department instructions.
- 10) **Noncompliance.** Sourcewell reserves the right to seek all remedies available at law for unpaid or underpaid Administrative Fees due under this Agreement. Failure to remit payment, delinquent payments, underpayments, or other deviations from the requirements of this Agreement may be deemed a material breach and may result in cancellation of this Agreement and disbarment from future Agreements.

- 11) **Audit Requirements.** Pursuant to Minn. Stat. § 16C.05, subdivision 5, the books, records, documents, and accounting procedures and practices relevant to this Agreement are subject to examination by Sourcewell and the Minnesota State Auditor for a minimum of six years from the end of this Agreement. Supplier agrees to fully cooperate with Sourcewell in auditing transactions under this Agreement to ensure compliance with pricing terms, correct calculation and remittance of Administrative Fees, and verification of transactions as may be requested by a Participating Entity or Sourcewell.
- 12) **Assignment, Transfer, and Administrative Changes.** Supplier may not assign or otherwise transfer its rights or obligations under this Agreement without the prior written consent of Sourcewell. Such consent will not be unreasonably withheld. Sourcewell reserves the right to unilaterally assign all or portions of this Agreement within its sole discretion to address corporate restructurings, mergers, acquisitions, or other changes to the Responsible Party and named in the Agreement. Any prohibited assignment is invalid. Upon request Sourcewell may make administrative changes to agreement documentation such as name changes, address changes, and other non-material updates as determined within its sole discretion.
- 13) **Amendments.** Any material change to this Agreement must be executed in writing through an amendment and will not be effective until it has been duly executed by the parties.
- 14) **Waiver.** Failure by Sourcewell to enforce any right under this Agreement will not be deemed a waiver of such right in the event of the continuation or repetition of the circumstances giving rise to such right.
- 15) **Complete Agreement.** This Agreement represents the complete agreement between the parties for the scope as defined herein. Supplier and Sourcewell may enter into separate written agreements relating specifically to transactions outside of the scope of this Agreement.
- 16) **Relationship of Sourcewell and Supplier.** This Agreement does not create a partnership, joint venture, or any other relationship such as employee, independent contractor, master-servant, or principal-agent.

Any sublicense granted will be subject to the terms and conditions of this Article. Each party will be responsible for any breach of this section by any of their respective sublicensees.

**c) Use; Quality Control.**

i) Neither party may alter the other party's trademarks from the form provided and must comply with removal requests as to specific uses of its trademarks or logos.

ii) Each party agrees to use, and to cause its Permitted Sublicensees to use, the other party's trademarks only in good faith and in a dignified manner consistent with such party's use of the trademarks. Each party may make written notice to the other regarding misuse under this section. The offending party will have 30 days of the date of the written notice to cure the issue or the license/sublicense will be terminated.

d) **Termination.** Upon the termination of this Agreement for any reason, each party, including Permitted Sublicensees, will have 30 days to remove all Trademarks from signage, websites, and the like bearing the other party's name or logo (excepting Sourcewell's pre-printed catalog of suppliers which may be used until the next printing). 



VIDIZMO's open architecture framework allows for seamless integration with existing law enforcement and public safety systems, ensuring operational continuity and efficiency. Our REST APIs, Webhooks, and HTML Widgets provide agencies with multiple integration pathways to connect VIDIZMO with their existing infrastructure.

VIDIZMO's integration capabilities have enabled several customers to automate their workflows including The Georgia Attorney General's Office, which integrated VIDIZMO DEMS with their Law Enforcement Management System (LEMS) using REST APIs, enabling automated video evidence ingestion, seamless metadata tagging, and improved searchability and case management efficiency.

#### SOLVING CRITICAL PUBLIC SAFETY CHALLENGES WITH PROVEN SUCCESS

VIDIZMO has a strong track record of helping law enforcement, government agencies, and justice departments tackle complex challenges, particularly in digital evidence management, video content security, automated redaction, and training modernization. Below are real-world examples of how we've addressed key pain points for public safety organizations.

##### 1. Secure & Efficient Digital Evidence Management for Criminal Investigations

Law enforcement agencies must handle large volumes of digital evidence, ensuring chain of custody, secure sharing, and rapid access to mission-critical files. However, many agencies struggle with outdated, siloed, and unsecured storage solutions.

##### 1a. Georgia Attorney General's Office

The Georgia Attorney General's Office serves as the state's chief legal authority, overseeing legal guidance and law enforcement collaboration. Managing digital evidence from 29 to 50 law enforcement agencies posed challenges, as their existing LEMS system on AWS S3 lacked playback, advanced search, and redaction capabilities. Reviewing evidence was manual and inefficient, and handling FOIA requests required time-consuming redaction. Additionally, monitoring live surveillance footage in high-crime areas was difficult without a streamlined evidence review system.

VIDIZMO DEMS was integrated with LEMS, enhancing evidence accessibility with AI-powered search, automated ingestion, and metadata tagging. Legal teams could now quickly locate and analyze digital evidence, eliminating manual inefficiencies.

VIDIZMO Redactor enabled automated redaction of personally identifiable information (PII), ensuring compliance with FOIA and court regulations. Additionally, VIDIZMO's live surveillance integration allowed law enforcement to monitor and store crime scene footage efficiently, improving response times.

The Georgia AG's Office now benefits from a secure, AI-driven digital evidence management system that streamlines legal processes and enhances investigative collaboration.

##### 1b. California DMV

The California DMV, responsible for vehicle registration and fraud investigations across 170 field offices, faced difficulties in managing digital evidence. Investigators stored evidence on CDs and thumb drives, making retrieval slow and collaboration between offices inefficient. Decentralized storage increased security risks and compromised the chain of custody, while Internal Affairs faced restricted access to critical case evidence, limiting transparency.

VIDIZMO DEMS centralized the DMV's digital evidence on Azure Government Cloud, enabling secure, remote access to case-related files. Automated transcription and metadata tagging enhanced searchability, saving investigators significant time. Role-based access control protected sensitive information while ensuring appropriate visibility for authorized personnel. Internal Affairs received a dedicated evidence portal, allowing them to manage classified investigations securely. The implementation streamlined investigations, improved



collaboration across field offices, and ensured compliance with legal standards, providing a structured and tamper-proof approach to evidence management.

#### 1c. Adam's County

The Adams County Sheriff's Office struggled with disorganized evidence management, relying on physical media such as DVDs and hard drives to share evidence with courts and neighboring agencies. This method delayed investigations, increased security risks, and lacked clear access controls. Ensuring an audit trail and maintaining long-term evidence retention were also key concerns.

VIDIZMO DEMS provided a secure, centralized evidence repository, allowing role-based access for legal teams through dedicated portals. Prosecutors and public defenders could securely access relevant evidence without manual submissions. Integration with Azure SSO enabled seamless access for officers, while multi-view streaming allowed investigators to analyze footage from multiple perspectives simultaneously. The system also introduced long-term evidence retention and archiving features, improving compliance and security. Automated redaction tools ensured sensitive data remained protected, making case processing faster and more efficient while eliminating reliance on physical storage media.

#### 1d. DuPage County Illinois Sheriff's Office

The DuPage County Sheriff's Office faced inefficiencies in evidence handling, with files scattered across USB drives, DVDs, and portable hard drives. While SharePoint was introduced for sharing, it lacked security controls, making it impossible to prevent unauthorized downloads or modifications. This posed risks to evidence integrity and compliance with legal standards.

VIDIZMO DEMS centralized all digital evidence, improving organization, security, and tracking. Administrative controls ensured restricted access to sensitive case files, preventing unauthorized alterations. Built-in tamper detection allowed the office to track all activities related to evidence, ensuring legal credibility. Investigators benefited from advanced search and automated transcription, significantly reducing the time needed to retrieve case-related evidence.

The system's redaction capabilities allowed for secure sharing of case files while protecting personally identifiable information. By eliminating the risks associated with physical media and unstructured storage, VIDIZMO enabled the Sheriff's Office to manage digital evidence efficiently, ensuring secure collaboration and compliance.

#### 2. Automated AI-Powered Redaction for Privacy & Compliance

With increasing public safety surveillance and body-worn camera footage, agencies face challenges in complying with privacy regulations such as FOIA, CJIS, and GDPR. Manually redacting personally identifiable information (PII), such as faces, license plates, and identities of minors, is time-consuming and inefficient, leading to delays in responding to public records requests. VIDIZMO's redaction capabilities directly addresses this issue through its AI Powered Redaction Solution.

#### 2a. Major County in California

One of the largest counties in California faced a privacy challenge while analyzing 1.1 million annual call recordings for experience management and service improvement. These calls contained Personally Identifiable Information (PII), including names, phone numbers, and Social Security Numbers (SSNs), making it legally impossible to share them with external analytics providers due to California's stringent data privacy regulations (CCPA, CPRA). To proceed with analysis, the county needed a secure redaction solution that could automatically remove sensitive information while keeping the recordings usable for insights. Additionally, the solution had to be deployed within the county's own infrastructure to ensure compliance with state regulations.

VIDIZMO Redactor provided bulk audio redaction, allowing the county to automate the removal of PII from thousands of call recordings efficiently. By deploying Redactor within their private cloud, the county ensured that sensitive data never left state jurisdiction, maintaining compliance with CCPA and CPRA. The AI-powered solution streamlined the privacy protection process, allowing them to safely share redacted recordings with third-party analytics providers. This eliminated legal barriers to service improvement while maintaining the security and privacy of residents' data. By implementing VIDIZMO Redactor, the county successfully scaled its redaction process, ensured data compliance, and improved operational efficiency in service evaluation.

#### 3. Enhancing Law Enforcement Training & Compliance with Video Management

##### 3a. Baltimore Police Department

The Baltimore Police Department plays a critical role in public safety, with its Police Academy serving as the primary training ground for law enforcement personnel. However, managing live training sessions across multiple classrooms proved challenging due to the lack of a centralized system for viewing and supervising sessions in real-time. Police heads struggled to oversee multiple training streams simultaneously, and without a consistent streaming infrastructure, managing live events and encoders was complex. The inability to

record live sessions for on-demand review further limited the department's ability to provide feedback and improve training programs. Budget constraints also added to the challenge, making it difficult to maintain server performance while ensuring high-quality training experiences.

VIDIZMO EnterpriseTube provided a centralized solution for the Baltimore Police Academy, allowing them to efficiently manage live training sessions. A single-page portal was created, where all classroom streams could be viewed in real time, enabling better supervision and evaluation. The system established persistent live stream links for each encoder, ensuring reliable access to training content while integrating seamlessly with their Learning Management System (LMS), such as Blackboard or Canvas. Training sessions could now be recorded and stored for on-demand access, allowing police heads to review materials and provide constructive feedback. EnterpriseTube also provided secure storage for sensitive training materials, ensuring restricted access to authorized personnel only.

By adopting VIDIZMO, the department improved training efficiency, eliminated complexities in managing multiple streams, and ensured a cost-effective solution that met their budgetary constraints.

3b. California Department of Corrections and Rehabilitation (CDCR)

CDCR oversees prison management and rehabilitation programs across California, requiring a secure platform to stream live and on-demand video content for internal training and communication across its 30+ facilities. They needed a solution to facilitate secure information-sharing between different correctional centers, live town hall meetings for real-time updates, and a public-facing video portal for external communications, all while maintaining strict access controls to prevent unauthorized viewing. Security was a top priority, necessitating a deployment model that prevented sensitive internal content from being accessed by the public.

VIDIZMO EnterpriseTube provided a secure, scalable video streaming solution deployed on-premises and integrated with Wowza servers, ensuring that CDCR could stream live and recorded content with role-based access control. The system enabled segregated access by implementing multitenancy, allowing CDCR to manage internal and public-facing content separately while avoiding complex manual permissions. EnterpriseTube provided a hybrid infrastructure, allowing CDCR to store confidential training videos on-premises while hosting public-facing content in the cloud. With EnterpriseTube, CDCR streamlined its internal communications, enabled real-time updates across multiple locations, and improved accessibility to training materials, ensuring secure and efficient content distribution across their facilities.

3c. US Department of State

As the lead foreign affairs agency, the US Department of State (DOS) needed a high-performance video streaming and content management system to maintain communication with over 270 embassies and consulates worldwide. DOS struggled with latency issues, inconsistent video quality, and difficulties in delivering simultaneous live broadcasts to its global workforce of over 120,000 employees. Additionally, ensuring secure delivery of confidential video content while maintaining access control was a major challenge. Without a centralized and scalable video management system, managing electronic program guides, scheduling live broadcasts, and ensuring seamless distribution became increasingly difficult.

VIDIZMO EnterpriseTube offered a secure, white-labeled video content management solution that enabled scalable live and on-demand streaming for DOS's global operations. The platform reduced latency issues, optimized bandwidth usage, and maintained consistent video quality for events such as town hall meetings and diplomatic briefings. EnterpriseTube's integrated scheduling system provided a structured approach for organizing broadcasts while allowing embassies and consulates worldwide to stay informed. End-to-end encryption and access controls ensured that confidential policy updates and classified communications were securely distributed, only accessible to authorized personnel. The solution was device-agnostic, allowing staff to stream content from any device, increasing accessibility and operational efficiency while reducing infrastructure costs. With EnterpriseTube, the US Department of State established a secure, scalable, and high-quality streaming solution, ensuring seamless global communication and content management.

3d. The Missouri Department of Revenue (DOR) needed a SCORM-compliant platform to host and manage 300GB of training videos for its Motor Vehicle Driver License (MVDL) division. Their existing compliance and training system lacked video hosting capabilities, preventing effective distribution of training content to employees. Ensuring course completion tracking and interactive assessments was also critical, as was the ability to support live training sessions for new employees. Additionally, they required AI transcription for subtitles, improving accessibility and engagement.

VIDIZMO EnterpriseTube provided SCORM-compliant video hosting, allowing MVDL to upload, organize, and distribute training content seamlessly. The platform enabled interactive learning, incorporating unskippable quizzes within videos, ensuring employee engagement and



compliance with training requirements. Live streaming capabilities allowed Missouri DOR to conduct real-time training sessions, extending accessibility across the state. AI-powered transcription and multilingual subtitles improved inclusivity, ensuring that training materials were comprehensible to all employees. By implementing EnterpriseTube, Missouri DOR successfully modernized its training system, ensuring efficient content delivery, employee engagement, and compliance tracking across its workforce.
