Sourcewell included multiple solicitations within the RFP with the intention of awarding multiple contracts in the state of Utah.

Proposal Evaluation Method

The Sourcewell Proposal Review Committee first determined responsiveness of all proposals. A responsive proposal must have been submitted on time and materially satisfy all mandatory requirements identified in the RFP. Responsive proposals were then evaluated in accordance with the criteria set forth in RFP section VIII. Evaluation and Award. Proposers submitted five adjustment factors for each contract opportunity within the region to the fixed prices in the Construction Task Catalog. The submitted proposal adjustment factors were weighted as more fully described in the RFP to determine a single combined adjustment factor. This combined adjustment factor was then used in determining the pricing score for each proposal. Proposers may not be awarded more than one same scope Contract within a Region.

Findings of the Proposal Evaluation Committee

The Sourcewell RFP required proposers to upload all current, applicable required licensure(s). Johnson-Laux Construction did not provide a Utah license and were found to be non-responsive. A certificate of good standing dated within twelve months of this solicitation's close date was also a mandatory upload and was not provided by Calvin L Wadsworth Construction Company LLC and they were therefore determined to be non-responsive. Proposal submissions were reviewed thoroughly according to the RFP Specifications with awards going to the following:


