Their sales and service network is strategically designed to ensure comprehensive coverage across North America with representatives located regionally. TRANSET offers beneficial pricing to Sourcewell participating entities.

United Parcel Service (UPS) has been operating shipping and delivery services since 1907. UPS has over 5,300 stores, 17,000 drop box locations, and 400,000 employees in the United States. Under this contract, UPS will serve the United States with expedited and standard delivery of documents, packages of various sizes and weights, hazardous materials, perishable goods, high value, or restricted cargo. STATEMENT OF COMPLIANCE


