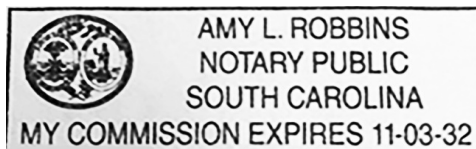

# NCAA still shortchanging women’s game

TAMPA, Fla. – Once again, it’s the people who should most want to promote the women’s game who are holding it back.

For all the strides it’s made since the great weight room debacle of 2021, the NCAA is still shortchanging the women. A TV contract that undervalues the Women’s NCAA Tournament. A format that undersells the fan base and does a disservice to the “student-athletes.”

How many more times do the women need to prove themselves before the NCAA gets that this is not a passing fad?

“I don’t want to come across as somebody who is ungrateful or all that because I’ve benefited so much,” UConn coach Geno Auriemma said Saturday, a day before his Huskies won their 12th national title.

“But I do think that sometimes we are being held hostage by tradition. ‘This is the way we’ve always done it. It’s easy. It’s simple. It’s uncomplicated.’ But why? Why not go out there and look at what other people are doing and take their best practices?” Auriemma said. “Because it can make us money and it can put us at a higher profile.”

There is no question the NCAA is doing better by the women’s game than it was five years ago, finally assigning the tournament a monetary value and awarding teams “units” – financial compensation – for their participation.

But this is a low bar. The NCAA could have sold the women’s tournament on its own last year, for far more than its current \$65 million valuation. Instead, it agreed to a deal with ESPN that bundles women’s basketball with softball, volleyball, gymnastics, underwater basket weaving and any other championship there is.

Why? That’s an excellent question. The deal was signed before the boffo ratings for last year’s NCAA Tournament, when the women’s final outdrew the men’s for the first time. But interest and ratings were already trending upward, and the NCAA didn’t trust the women to keep it going.

And yet ratings for the first two weekends of the Women’s Tournament were up 47% over 2023, the most accurate comp. The 4.1 million who turned in for UConn’s rout of UCLA in the Final Four

on Friday night was down significantly from the Caitlin Clark era but still the third-highest rated in the 30 years ESPN has been broadcasting the tournament.

Worse, the new deal is a long-term one, running through 2032. Now, you can look at the men’s TV deal and see that they’re both expiring in 2032 and wonder if the NCAA has a plan to package the tournaments together. But that’s no excuse for not giving the women their fair market value now.

“There are certain things that we need,” South Carolina coach Dawn Staley said. “Open up the negotiations for a new television deal would be nice. We need our own television deal so we can understand what our worth is.”

Speaking of worth, the NCAA has locked the women’s Final Four into basketball arenas through 2031 while the men will continue playing in domes. Watching a basketball game in a dome is a miserable experience, not ideal for players or fans. But when has that mattered?

On Sunday morning, the get-in price for a ticket to the women’s title game was \$100 more than for the men’s championship matchup. Yes, the Alamodome is bigger. A lot bigger. But that’s the point. The demand is there. Why not put the women’s Final Four in a dome, too, and at least see what happens?

Same for the regionals.

The NCAA went to a “super regional” format in 2023, hoping it would boost attendance and entice more cities to want to host. The format has some flaws – lack of enough practice venues, limited hotels for fans – but the biggest issue is the cities in which they’re held and the schedule.

Spokane, Washington, is lovely and does a great job of hosting NCAA events. Ditto for Birmingham, Alabama. But the tournament has outgrown cities of this size for the Sweet 16 and Elite Eight, and it needs to be accessible for more fans.

“What you’re saying when you have two regions is you don’t care if half the country can’t get to a game. Basically, that’s what you’re saying. But yeah, you want to grow the game. I mean, come on, it makes no sense,” Auriemma said. “If you ever had an administrator that ever coached or ever played in a Final Four or regional, and you realize what the limitations are in one gym with eight (teams), right? Yeah, but they don’t think that way. They don’t think that way.”

And you cannot expect women’s players to accept inconveniences that you do not ask of the men.

UConn played in the last Elite Eight game, with its win over Southern Cal in Spokane ending about 11:30 p.m. Eastern last Monday. The Huskies tipped off again about 9:30 p.m. Eastern on Friday.

The last Elite Eight men’s game, meanwhile, wrapped up about 8 p.m. last Sunday and the first Final Four game wasn’t until 6 p.m. on Saturday.

Auburn, the last team in, just had to go from Atlanta to San Antonio, too. Not clear cross country like UConn did.

“One of the big differences in the way women’s basketball is run today and men’s basketball was run is that you have really true basketball people making basketball decisions on the men’s side,” Auriemma said.

“This isn’t sour grapes, because I don’t give a godd--- where we play, when we play, who we play, what town, because we’ve done it and we still end up here,” he added. “So this isn’t about, you know, ‘Geno’s complaining.’ I’m not complaining about anything. I’m just telling you the student-athletes, their experience sucks compared to the men’s experience.”

Asked on Friday night about complaints from Auriemma and other high-profile coaches, NCAA President Charlie Baker said there isn’t much the organization can do because of its existing contracts.

“(The women’s basketball committee) will do a download at the end of the tournament and discuss what they think makes the most sense. If they believe there’s an option that would create the same fan and student-athlete experience. I’m sure they’ll take it into consideration,” Baker said.

They need to do more than that.

The Final Four is in Phoenix next year. Ask organizers to move it to State Farm Stadium. Ditto for 2028, when it’s in Indianapolis, another city with a dome. When the Final Four returns to the Alamodome in 2029, expanding capacity to what it was for the men’s title game Monday night should be a no-brainer.

And you can’t tell me Jerry Jones wouldn’t throw open the doors to Jerry World when the Final Four returns to Dallas in 2031.

“We certainly have the players that can handle that profile and there’s going to be more of them coming along,” Auriemma said. “We don’t want to shortchange them. We don’t want to sell them short, you know?”

Change is hard, especially when there are decades of misogyny baked in. But if the people making decisions at the NCAA can’t see that they’re short-changing female athletes and themselves, they need to get out of the way and put someone in charge who does.

# President optimistic about deal, a federal bill

SAN ANTONIO – Amid significant skepticism within college sports that the House vs. NCAA settlement will bring calm and order to the financial relationships between athletes and schools, NCAA President Charlie Baker said Saturday the system outlined in the settlement will be “far better than what we are dealing with” if ultimately approved and implemented.

A final hearing on the settlement and various objections to the terms was held Monday in front of U.S. District Court Judge Claudia Wilken, but the NCAA expects and hopes it will be approved without significant changes.

The key element of the settlement with regard to the future structure of college sports is a revenue sharing agreement and a third-party clearinghouse that will police name, image and likeness (NIL) deals to determine whether they are within the range of fair market value.

The NCAA entered into an agreement recently with Deloitte to run the clearinghouse.

Some administrators and coaches

have questioned whether it’s even possible to accurately gauge fair market value of NIL deals being offered to athletes and whether attempts to punish schools for trying to circumvent what amounts to a salary cap will spawn another round of lawsuits.

Baker said that having some structure around NIL and the ability to collect data about how much money schools are spending on their athletes in various sports will be beneficial to the overall environment.

“Right now we have nothing like that,” Baker said. “We don’t have any way to gauge or judge exactly what’s going on out there. It’s all anecdote and representation, which is not really very helpful if you’re trying to determine what’s really happening.”

“At minimum, what we’re going to get out of this is two processes, both of which will have real elements to them around submission of information and approval. And over time, it will make it possible to aggregate that data.”

Of course, one of the reasons the settlement won’t necessarily protect the NCAA from being sued over various regulation attempts in the future is its inability to get congressional action on an

antitrust exemption or other law that would protect its model despite more than five years of intense lobbying.

Baker, the former governor of Massachusetts, was in fact hired to replace Mark Emmert largely because of his political background as college presidents increasingly saw lawmakers as their best path toward stability.

But no bill has been brought to the floor in either chamber of Congress despite multiple hearings on college sports, and it’s uncertain when or if there will eventually be a proposal that can pass the House of Representatives and get 60 votes in the Senate.

The current political environment, with a closely divided partisan split and several hot-button issues dominating the conversation both domestically and abroad, probably does not lend itself college sports’ issues being a priority in Washington, D.C.

“That doesn’t mean you shouldn’t try,” Baker said. “And sometimes interesting things happen.”

“We spent a lot of time talking to people on both sides of the aisle, both branches, and in the privacy of their offices I think there is a path forward here. We’ll see if we can get there.”

# Rose falls in playoff for second time

AUGUSTA, GA – While Justin Rose holds the dubious distinction of losing a pair of Masters tournament playoffs, there might be few in the game equipped to handle it like him.

The 44-year-old fell to Rory McIlroy on the first playoff hole April 13, mirroring his outcome in 2017 against Sergio Garcia.

Following a stellar 65 in the opening round, Rose seemed to fade after stumbling through the second nine in the third round. Instead of dwelling on the setback, he turned that anger into determination to flip the script.

“Definitely I’m proud of myself. I think – yeah, played great golf today. Came out – I think I flipped the switch from yesterday. Yesterday I was so angry coming off the golf course because I turned 69 into 75 yesterday. I didn’t let that momentum seep into today, and I think that that was, from a professionalism point of view, very, very proud of that switch overnight and into this morning.”

Was it his best round, ever? Some might say 10 birdies – and eight over the final 12 holes – might make it such. We are talking about the 2013 U.S. Open champion, after all.

“I mean, nearly. It’s a bogey away from being the greatest round I’ve ever played,” he said. “It is, it is a great round. I think if you look at the quality of golf, it possibly, possibly is.”

At the time, a chance to force a playoff seemed unlikely. Rose drained a 20-foot birdie putt on No. 18 but had to wait for McIlroy to leave the door open. A missed short putt on the 72nd hole from the 35-year-old pushed the duo into a sudden-death playoff on No. 18.

McIlroy proceeded to hit his second shot 4 feet from the pin, setting up the winning putt.

“Unfortunately, the playoff, they always end so quickly. You know, that’s sudden death,” Rose said. “You don’t really get an opportunity. If you’re not the guy to hit the great shot or hole the great putt, it’s over. So I felt like, that’s the nature of sudden death. But not really anything I could have done more today.”

In his 20th Masters start, and now a three-time runner-up, it would be easy to dwell on this for months, or even years. Rose has been around long enough to know how to compartmentalize the disappointment and focus on the positives.

“Yeah, it hurts. I think – you know, yeah, what are you going to do about it, though? I think I’ve already kicked on in my career when I finished second to Sergio here. By then played some of the

best golf of my career, got to world No. 1,” he said.

“What do you choose to dwell on, you know what I mean? There’s no point in being too despondent about it and you look at all the good stuff that got me into this situation. You can’t skip through a career without a little bit of heartache. It’s not going to happen.

“If you’re willing to lift the big championships, you’ve to put yourself on the line. You have to risk feeling this way to get the reverse. It’s all – it nets out.”

Despite the loss, the gravity of McIlroy’s win isn’t lost on Rose, forever a student of the game. He was the first one to congratulate his opponent not only on the Masters win, but also the career Grand Slam.

“Yeah, Rory is a friend for sure,” Rose said. “... When it’s all said and done, I said to him, ‘Listen, I was glad I was here on this green to witness you win the career Grand Slam.’ That’s such a cool, momentous moment in the game of golf. Yeah, that was it. He was obviously pretty overcome with emotion and probably not going to be able to take in much at the time. But yeah, I mean – yeah, that’s – it was a big day in golf.”

McIlroy said he and Rose joined a few Augusta National Golf Club members for dinner the night of April 8. Who knew the two would meet again on golf’s biggest stage just six days later?

The 2025 Masters champion reciprocated the respect during his championship press conference.

“I remember watching the playoff in ’17 when he went up against Sergio, and that didn’t quite go his way, either,” he said. “But he’s had a phenomenal record around here, and I feel for him a little bit because he’s been so close.

“Yeah, he’s a good friend, and yeah, hopefully he has a few more opportunities.”

## Scottie Scheffler’s repeat chances come up short

AUGUSTA, GA – Vying to become the tournament’s fourth back-to-back champion, Scottie Scheffler fell short at the 89th Masters, ending at 8-under par.

“I just didn’t have my best stuff this week,” he said following a 69 April 13 at Augusta National Golf Club.

Scheffler’s 280 total was enough for a top-5 finish, his third in six starts at the Masters. “A few different things happen today and I maybe have a chance in the tournament,” the world No. 1 said. “I wasn’t far off.”

Following Rory McIlroy’s miscues on the 13th and 14th holes, Scheffler trailed by two shots as he played No. 16. Stand-

ing on the tee box, Scottie told himself to finish the tournament with three straight 3’s.

“I felt like I had to birdie the last three holes,” he said.

It didn’t happen.

Scheffler played his final five holes with pars on each, while paying steady attention to the fluctuating leaderboard.

“I forgot kind of what it’s like when they post stuff on the leaderboard,” Scheffler admitted. “I think the two Sundays I’ve had here where I was able to win, I was kind of ignoring what was going on on the leaderboard.

“Going down the stretch today was different. I forgot what it’s like when they post the numbers. It was a bit of a roller coaster out there.”

## DeChambeau tumbles down leaderboard as iron play goes awry

AUGUSTA, GA – Following his third-round 69, Bryson DeChambeau was escorted to Augusta National’s Press Building. He didn’t begin with the birdies on Nos. 15 and 16. He didn’t lead with his 48-foot bomb on 18.

“I’m excited and ready to go to the practice range,” DeChambeau stated with his first sentence. “Need to go work on my iron play.”

Iron play.

If the clubs knocked DeChambeau down on April 12, they knocked him out April 13.

The LIV Golf star, who held a one-stroke lead after the second hole in the fourth round, played his final 16 in 4 over for a 75.

“Just more of the same with my irons,” he said after the disappointment. “If I had somewhat of good iron play this week, it would have been a different outcome. But could have, should have, would haves. You’ve got to do it.”

As for his interaction with Rory, his playing partner, Bryson said, “Didn’t talk to me once all day.”

After making birdie at No. 2, DeChambeau three-putted the third. And when McIlroy birdied the hole, the lead flipped for good.

“Feeling awesome. Felt in control,” DeChambeau said about his brief stint as solo leader.

“The third hole, hit it up there to 20 feet, I’m like, ‘OK, that’s exactly the

way I wanted to play the hole,’ ” he said. “And that putt, I’ve never seen a putt faster than that. Those greens got really fast. The agronomists here at Augusta National, they know how to play complete tricks on you.”

After the misread on No. 3, his iron play went awry, finding the front bunker on No. 7, water at the 11th, water at the 15th and another miss left at 17.

“Got to get better,” DeChambeau bluntly said. “More room for improvement. Excited, though.”
