## The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee used the Sourcewell RFP evaluation criteria and determined that all proposal responses met Level-One Responsiveness. The responses from Ennis Flint, Inc. and Sightline, Inc. were determined to be Level-Two non-responsive because the offerings of products and services were found to fall outside of the Requested Equipment, Products or Services of the RFP. All other proposals were found to be Level-Two responsive and were evaluated.
