## The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that the products and services offered in the proposal response from NextEra Mobility, LLC fell outside of the Requested Equipment, Products, or Services of the RFP. All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

Mansfield Oil of Gainesville offers supply and delivery of all formulations, grades, and blends of motor vehicle, aviation, and heating fuels across the U.S and Canada. Their sales staff will work throughout the United States and Canada utilizing their 11 locations to serve Sourcewell participating entities. Mansfield also offers fuel cards, inventory management, fuel additives and preventative maintenance on facilities. They offer an OPIS plus differential pricing model.

Saratoga Rack Marketing, LLC has a long history of providing motor vehicle fuels in the United States. They can provide a full complement of vehicle fuels, alternative fuels, and their delivery service with various types of deliveries including mixed drops and the ability to fill above and underground tanks. Their 24-hour fulfillment center offers Sourcewell participating entities around the clock service. Their delivered price structure allows participating entities to know what they are paying for the products.

TACenergy, LLC offers a full line of fuels (gasoline, diesel, heating oil) renewable diesel and aviation fuels, biodiesel, ethanol and, DEF. Their sales staff and network of terminals throughout the United States allow them to serve Sourcewell participating entities in the U.S. Their sales model allows them to lock in freight charges for an entire year with a commensurate commitment from the agency. They are offering pricing based on a negotiated benchmark allowing them to commit to pricing for each participating entity.
