The findings of the Proposal Evaluation Committee are summarized as follows:

Proposals were received in sealed packages from Mondo USA and Putterman Athletics, after the deadline for delivery. The untimely packages were returned, unopened, to Mondo USA and Putterman Athletics in accordance with the RFP terms.

The Proposal Evaluation Committee used the Sourcewell (formerly NJPA) RFP evaluation criteria and determined that all proposals met Level-One responsiveness. All proposals, with the exception of Grand Slam Safety, LLC, met Level-Two Responsiveness and were evaluated. The proposal of Grand Slam Safety, LLC, was determined to be Level-Two non-responsive because all products and services offered within the proposal were found to fall outside of the scope of the RFP.

The Proposal Evaluation Committee determined that clarification of Astroturf Corporation's response to Form A, Question 5, was required. Sourcewell issued a request for clarification to Astroturf Corporation pursuant to RFP Section 6.13. Astroturf provided the requested clarification and submitted sufficient additional financial documentation for review by the Committee. The Proposal Evaluation Committee thereafter evaluated all of the responsive proposals.

Astroturf Corporation offers manufacturing and installation of synthetic turf systems, running track surfacing systems and tennis court surfacing. Astroturf has direct sales representatives throughout the country along with a distribution network focused on each vertical including maintenance packages. Astroturf offers a competitive discount and volume pricing for multiple field or court purchases.
