#### **Fabric Structures with Related Materials and Services**

The following advertisement was placed July 25, 2019 in Utah's *The Salt Lake Tribune*, in *USA Today*, in South Carolina's *The State*, and on the Sourcewell website <a href="www.sourcewell-mn.gov">www.sourcewell-mn.gov</a>, Sourcewell Procurement Portal <a href="https://proportal.sourcewell-mn.gov">https://proportal.sourcewell-mn.gov</a>, Biddingo, Merx, The New York State Contract Reporter <a href="www.nyscr.ny.gov">www.nyscr.ny.gov</a>, PublicPurchase.com, and July 26, 2019 in Oregon's *Daily Journal of Commerce*:

In addition, Calhoun offers repair and recover services no matter the level of damage, size or brand. They have a strong project team and dealer network in the United States and Canada ready to serve Sourcewell Members. They utilize 3D Non-Linear Finite Element Analysis which considers climate and seismic conditions at the building location to deliver a suitable building for each unique location. Calhoun Super Structure is offering Members a significant discount off list price.

ClearSpan Fabric Structures International offers rigid frame fabric structures, on-site consultations, site evaluations, measurements and installation. They have a sales force that is available to Members in the United States and Canada. Their fabric covers are 100% recyclable and the recycled content of the steel framework may contribute to a project's eligibility for LEED certification. ClearSpan offers Members a competitive discount on pricing with a noteworthy warranty on covers and frames.
