

**AGREEMENT TO
MODIFY AND EXTEND
SOURCEWELL CONTRACT #NM-R1-GC-060222-GMB**

THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #NM-R1-GC-060222-GMB, is effective upon the date of the last signature below.

Sourcewell and GM Builders, Inc. (“Contractor”) have entered into an Indefinite Quantity Construction Contract, Contract Number **NM-R1-GC-060222-GMB**, with an initial term ending June 27, 2023, and two bilateral options to extend for an additional one-year term (“Contract”). The parties agree that the Contractor’s Adjustment Factors will be modified, and that Sourcewell’s offer of a one-year extension term will be accepted by Contractor.
