

**MODIFICATION AND EXERCISE OF OPTION #1  
TO

THIS MODIFICATION AND EXERCISE OF OPTION #1 is effective upon the date of the last signature below by and between Sourcewell and Place Services, Inc., Contractor.

Sourcewell and Contractor have entered into an Indefinite Quantity Construction Contract, Contract Number **OH-R1-E01-102021-PLA**, with an effective date of November 3, 2021, an initial term of one year, and three bilateral options to extend for an additional one-year term. The parties agree that the Contractor's Adjustment Factors will be modified, and that Sourcewell's offer of a one-year extension term will be accepted by Contractor.





THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #OH-R1-E01-102021-PLA, is effective upon the date of the last signature below.

Sourcewell and Place Services, Inc. 
