THIS MODIFICATION AND EXERCISE OF OPTION #1 is effective upon the date of the last signature below by and between Sourcewell and Genesis 1 Construction, Contractor.

Sourcewell and Contractor have entered into an Indefinite Quantity Construction Contract, Contract Number **OH-R2-GC06-102021-GNS**, with an effective date of November 3, 2021, an initial term of one year, and three bilateral options to extend for an additional one-year term. The parties agree that the Contractor's Adjustment Factors will be modified, and that Sourcewell's offer of a one-year extension term will be accepted by Contractor.

IN CONSIDERATION OF the mutual covenants and agreements described in this Modification and Exercise of Option, the parties agree as follows:

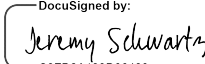

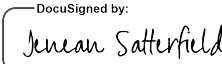

THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #OH-R2-GC06-102021-GNS, is effective upon the date of the last signature below.

Sourcewell and Genesis 1 Construction (“Contractor”) have entered into an Indefinite Quantity Construction Contract, Contract Number **OH-R2-GC06-102021-GNS**, with an initial term ending November 2, 2022, and two bilateral options to extend for an additional one-year term (“Contract”). 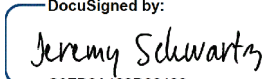

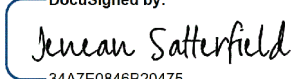
