THIS MODIFICATION AND EXERCISE OF OPTION #1 is effective upon the date of the last signature below by and between Sourcewell and Regency Construction Services, Inc., Contractor.

Sourcewell and Contractor have entered into an Indefinite Quantity Construction Contract, Contract Number **OH-R2-GC08-102021-REG**, with an effective date of November 3, 2021, an initial term of one year, and three bilateral options to extend for an additional one-year term. 



THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #OH-R2-GC08-102021-REG, is effective upon the date of the last signature below.

Sourcewell and Regency Construction Services, Inc. ("Contractor") have entered into an Indefinite Quantity Construction Contract, Contract Number **OH-R2-GC08-102021-REG**, with an initial term ending November 2, 2022, and two bilateral options to extend for an additional one-year term ("Contract"). 
