November 2021 - Sourcewell, North Texas, Dallas-Fort Worth Area


Pursuant to the agreement between the parties, the Adjustment Factors remain fixed for the duration of the contract.



THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #TX-NT-GC-101619-DHC, is effective upon the date of the last signature below.

The following is adopted as the new CTC for the Contract effective November 8, 2022:



EXERCISE OF OPTION: EXTENSION


