
Pursuant to the agreement between the parties, the Adjustment Factors remain fixed for the duration of the contract.



THIS AGREEMENT TO MODIFY AND EXTEND, Sourcewell Contract #TX-RGV-GC-021920-CCT, is effective upon the date of the last signature below.

Sourcewell and CORE Construction Services of Texas, Inc. (“Contractor”) have entered into an Indefinite Quantity Construction Contract, Contract Number **TX-RGV-GC-021920-CCT**, with an initial term ending March 5, 2022, and three bilateral options to extend for an additional one-year term (“Contract”). The following is adopted as the new CTC for the Contract effective March 6, 2023:



Contractor and Sourcewell hereby desire and agree to extend the Contract, with the above modification, for the period of March 6, 2023 through March 5, 2024.


