

COMMENT AND REVIEW

to the Invitation for Bids (IFB) on Indefinite Delivery Indefinite Quantity Construction Contracts VA-072023 – Commonwealth of Virginia

IFB

Sourcewell issued the Invitation for Bids (IFB) to provide Indefinite Delivery Indefinite Quantity Construction Contracts (IDIQ) jointly with and on behalf of current and potential Sourcewell Participating Entities, including all government agencies, education agencies to include colleges and universities, and non-profit agencies, within the Commonwealth of Virginia, as identified in the attached map of the regions. Sourcewell included multiple solicitations within the IFB with the intention of awarding multiple contracts in the Commonwealth of Virginia.

Advertisement

The IFB was advertised in the *Daily News Record, Richmond Times Dispatch, Roanoke Times, Virginian Pilot* and the *Washington Post* on June 8, 2023 and June 15, 2023. It was advertised in the *Fairfax County Times* on June 9, 2023 and June 16, 2023 It was posted to the Sourcewell website and the Sourcewell Procurement Portal for daily viewing and document download/response from June 8, 2023 until the scheduled due date and time:

Sourcewell, a State of Minnesota local government entity and public agency, is issuing this Invitation for Bids (IFB) jointly with and on behalf of its participating entities to create indefinite deliveryindefinite quantity construction (IDIQ) contracts that may be used by those participating entities for projects related to construction or the repair, alteration, modernization, or renovation of buildings, structures, or other real property.

This IFB consists of the following parts:

- 2. Template IDIQ Construction Contract
- 3. IDIQ Contract General Terms and Conditions
- 4. Construction Task Catalog

Bid Evaluation Method

The Sourcewell Bid Review Committee first determines responsiveness and responsibility of all bidders. A responsive bid must have been submitted on time and materially satisfy all mandatory requirements identified in the IFB. The bidders submitted three adjustment factors for each contract opportunity within the region to the fixed prices in the Construction Task Catalog. The submitted bid adjustment factors were weighted as more fully described in the IFB section to determine a single combined adjustment factor. This combined adjustment factor was then used in determining the ranking of the bids. Bidders may not be awarded more than one same scope Contract within a Region. The maximum number of contracts to be initially awarded by geographic region and contract type was identified in the IFB under Article VIII. Evaluation and Award.

Findings of the Bid Evaluation Committee

Bid submissions were reviewed thoroughly according to the IFB Specifications with awards going to the lowest responsive/responsible bidders. Clarification on ability to provide construction work in the Commonwealth of Virginia was requested from Toro Construction Corp, and a clarification request was sent to Paige Industrial Services, Inc to determine if they can self-perform 51% of the civil/site work and mechanical/HVAC work bid. Neither bidders responded to the requests for clarification. Toro Construction was determined to be non-responsive based on IFB section III A. Required bidder qualification, not meeting the requirement to ensure prompt and efficient service to a Sourcewell participating entity. Paige Industrial Services, was determined to be non-responsive to the Mechanical/HVAC and civil/site work bids in accordance with IFB section III. C, requirement for trade work to be performed by 51% or more of the bidder's own organization and forces. The selected contractors identified in the results below have the required experience with IDIQ Construction work, and all the awarded bids were determined to be competitive and reasonable for the area.


