

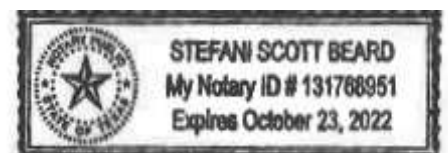



San Diego crime lab lapses come to light

Audits and internal reports detail security shortcomings and testing mistakes.

SAN DIEGO — In 2018, a team from the U.S. Justice Department arrived in San Diego for an audit of the San Diego Regional Crime Laboratory to determine whether the lab was meeting FBI standards, allowing it to be part of the national DNA database system.

The results were not great. Auditors found that security at the lab didn't meet FBI standards. The reason: Keycards, electronic passes that allow employees access to the lab and certain spaces within it, were not being kept track of.

Auditors found that a master list intended to track which employees had keycards was outdated and unreliable. Internal records showed half a dozen former employees and private contractors still had active keycards, even though they had long ago stopped working there — in one case a card remained active 14 years after its last use. In others, the time period ranged from

eight years to a dozen years.

Moreover, lab officials could not be sure that they had collected the keycards. The implications of such a security lapse were potentially huge, the report con-

cluded.

"This created a heightened risk of improper access to privacy information and evidence by unauthorized individuals, as well as compromising the chain of cus-

tody of the evidence," auditors wrote. "In addition, the security of the laboratory was put at risk."

Embarrassed lab officials did not contest the findings. They noted that there was no evidence the cards had been used over the years. And they said things would be different in a few months when the lab moved to a new \$107-million headquarters at the county's Clairemont Mesa campus.

New building, new keycards and, they said, a new policy would be in place by August 2018. But it was not until June 2020 that federal auditors formally closed the audit. That's because it took the lab months to provide documentation to satisfy auditors that they had fixed the issue.

In an email response to questions about the audits, the San Diego County Sheriff's Department said the delay was because it was not aware until December 2019 that more information was needed. Now, the statement said, the lab does security audits each quarter.

The keycard problem was one of several that surfaced in a review of years of audits and internal reports of the county lab conducted by the San Diego Union-Tribune.

Overall, the years of au-

dits generally gave good marks to the lab, which processes about 15,000 cases a year for nearly three dozen local, state and federal agencies. The lab has never lost its accreditation since earning it in 2003.

But some of its work over the years has become pivotal in the ongoing case of Jane Dorotik, a former San Diego County woman who was convicted in 2001 of murdering her husband, Robert. Much of the evidence in that case relied on the lab's work on bloodstains, crime-scene reconstruction and DNA.

Last year, after a team of lawyers from the Loyola Law School Project for the Innocent had taken on an appeal in her case and raised a series of issues about the lab, the San Diego County district attorney's office conceded that Dorotik did not get a fair trial in 2001, erasing the conviction.

Prosecutors want to put her on trial again. Since April, the two sides have been locked in a lengthy pre-trial hearing. And while that hearing has focused on the Dorotik investigation and the time period between 2000 and 2002, defense lawyers have been able to uncover evidence about mistakes in the lab before and after that time.

Their work led prosecutors to issue two "Brady letters," missives to the local defense bar stating that the work history of two former criminalists — Connie Milton and Charles Merritt — could affect their credibility as witnesses. The pair worked on hundreds of cases in their long careers, though the letters did not specify what cases, if any, could be affected.

Merritt retired in 2013 after 31 years in the lab. Milton retired this year after nearly 25 years.

The Union-Tribune reviewed more than a decade of audits and assessment reports as well as internal lab documents obtained through the Public Records Act and court records.

Although audits for many years gave the lab a clean bill of health, others identified a variety of issues. Many were seemingly minor, like not having a record retention policy for audits, or not providing documents to support the conclusion made by criminalists in a case. Or citing a cockroach problem in the forensic biology section of the lab's former building.

Others were more serious. A 2014 audit by the American Society of Crime Laboratory Directors focused on a key part of the lab's work — "technical reviews," where another criminalist scrutinizes a report prepared by a colleague for a piece of evidence, such as a DNA profile.

These are a standard part of crime lab work. But the audit found "multiple instances" where those reviews "were not sufficiently thorough to detect errors in the reports" in the crime-scene, fingerprint and trace-evidence sections of the lab.

In its response at the time, lab officials said they would discuss the reports that contained errors with both the analysts and reviewers, issue amended reports if necessary, and hold a general meeting to go over the technical review process. The internal documents included a review of a spate of errors involving switching samples in the lab's DNA section — essentially confusing one piece of genetic evidence from a person with another — between 2012 and 2014.

The lab commissioned an internal review in June 2014 of five such incidents — documented in internal lab reports known as "corrective actions" — to determine whether there were any common trends or ways to reduce the number of such errors, according to the report obtained by the Union-

Tribune. But the review did not turn up any such evidence.

"With the exception of attention to details, no one common cause can be determined," wrote Michelle Hassler, the lab's DNA technical manager.

The statement of the Sheriff's Department said one of the cases reviewed was a "data input error" and another involved conducting "an additional DNA analysis step than intended." It could not be determined whether the errors affected any cases from that time. The documents did not identify cases by name.

Suzanna Ryan, a DNA expert and forensics consultant, said sample-switch incidents were a concern. "That's one of the most serious errors in a lab," she said. Even though no common cause could be determined and they happened nearly a decade ago, the errors signaled a problem.

"If they caught five," she said, "the question is: Are there any occurrences they did not catch?"

Botched testing errors predated the sample switches reviewed by Hassler. In the 2011 murder trial of Marc Jernigan, court records that defense lawyer Christopher Plourd obtained had three dozen pages of lab records documenting a variety of errors in tests, many of them showing criminalists contaminating samples with their own DNA, or finding other unknown DNA profiles in the evidence.

Nearly all of the 38 reports, from four analysts including Milton from 2004 to 2008, have a handwritten note from a lab supervisor at the bottom reading, "No further action at this time."

Plourd, now a Superior Court judge in Imperial County, argued at the time that the documents showed not only an issue with Milton but also "an overall problem with the San Diego County Sheriff's Department crime laboratory as evidenced by the errors that routinely have occurred in the laboratory at and around the time of the DNA testing done in this case."

The Sheriff's Department said that when errors are identified, the criminalist's work is reviewed to determine the cause of the mistake, but that a review "does not encompass all work done."

Audits that discover problems are not unusual, Ryan said. "Any lab you look at, you are going to find errors," she said. "Most of the time they are errors that are minor or a one-time occurrence. You try to avoid them."

But Brandon Garrett, director of the Wilson Center for Science and Justice at Duke University School of Law, said "labs are supposed to have quality controls in place to make sure they don't make mistakes."

Garrett wrote a book on faulty forensic science and scandals in crime labs that revealed botched testing, falsified test results and other errors. He said audits only go so far.

"They are not a measure of quality in the lab," he said. Audits generally don't include techniques such as checking cases randomly to assess lab processes. He said labs also needed to be more transparent when errors were found.

He said if a hospital lab discovered a problem with a piece of equipment or errors by a lab worker, it would immediately compile a list of all the cases the equipment was used on or the employee worked on. "They would have a list of all patients," he said.

When asked whether the sample-switch errors affected any cases, the Sheriff's Department couldn't say, and referred questions to the district attorney's office.

Even though prosecutors notified defense lawyers about Merritt and Milton, the letters gave no specifics about which cases, or which tests, were flawed. Instead it told lawyers who believed they might have a case that was affected to contact a specific prosecutor.

How many have done that is not known. A spokesman for Dist. Atty. Summer Stephan said "a few defense attorneys have reached out with questions," but there have been no moves to re-examine cases.

Patience wears thin over homeless camps

[Smith, from B1] Culbertson at a loss for what do next, other than wait for action on a couple of new city policies that could beef up enforcement.

“Even the most liberal folks, like me, have begun to lose patience with the homelessness situation,” he admitted.

I thought about my conversation with Culbertson while listening to Los Angeles City Councilman Joe Buscaino on Tuesday, as he pitched a specious ballot measure that would bar homeless people from sleeping or camping in all public spaces if they have turned down shelter or housing.

“We all agree that the only solution to homelessness is housing,” he told his fellow council members. “Why would we continue to allow someone to continue to live on public property if a safer, healthier alternative is available? When we allow camping in public even when safer alternatives exist, we’re allowing someone’s addiction to take their lives.”

Buscaino wants to give whoever is mayor the authority to waive land-use and zoning rules “to urgently site homeless housing projects” and ramp up construction of emergency shelters.

“Contrary to what you’re hearing from advocates and others, this is not criminalizing someone for having no place to sleep,” he said Tuesday. “If there’s no appropriate shelter available, there will be no enforcement.”

Buscaino claims he is being driven by “mercy” and “compassion” for the tens of thousands of Angelenos who are living on sidewalks and under freeway bridges. But he also is running for mayor on a platform of cracking down on encampments.

Moreover, he has a habit of insinuating that many homeless people won’t accept help because they are struggling with drugs or mental illness when, in reality, many are just too poor to afford housing. So there are plenty of reasons to question the purity of his motives.

It’s not entirely surprising, then, that the City Council punted.

Rather than approve or

reject Buscaino’s request to have the city attorney draft language for his ballot measure, they shipped it to the Homelessness and Poverty Committee for an overhaul.

Some, including Councilman Mike Bonin, were particularly uneasy with the measure’s focus on enforcement and the prospect of forcing homeless people, en masse, into temporary emergency housing.

“Do we want to solve homelessness? Or do we want to address the problem of homeless encampments? This does the latter,” he said of the proposed ballot measure. “Homeless encampments are unacceptable, and they’re unsafe, and they’re unsanitary. But the way to get rid of homeless encampments is to get rid of homelessness ... by giving people housing.”

If only L.A. were ready for all that.

In response to the council’s action, Buscaino’s campaign vowed to collect the 65,000 signatures necessary to put the measure before voters on the June 2022 ballot.

He also criticized his

colleagues in a campaign email, saying they “are more interested in the right to sleep on the sidewalk than the right to housing.”

What’s striking about this rhetoric is how similar it is to what Sacramento Mayor Darrell Steinberg has been saying lately. And Steinberg, in contrast to Buscaino, is known in political circles for having compassion for the unhoused, both as author of California’s Mental Health Services Act and as co-chair of a statewide task force on homelessness.

Earlier this month, the mayor introduced what he calls a “right to housing.” It would require the city to provide enough permanent housing or, more likely, temporary shelter — be it sanctioned tent cities, hotel rooms or tiny homes — for every homeless person by 2023 or face possible lawsuits.

In return, homeless people would be required to accept whatever shelter or housing is offered by outreach workers. No cops would be involved.

Steinberg’s plan has gone over better with the

Sacramento City Council than Buscaino’s has with the L.A. City Council. But in both cities, homeless activists and progressives are united in their opposition.

“I understand the fear ... that this is just a hidden way to deal with the tent encampment issue and clean up the city,” Steinberg said during a recent council meeting. “My motive is not to make life harder for people; it’s to get people indoors, because I think living outdoors in these tent encampments is horrible.”

And like Buscaino, he has criticized those who would defend the right for people to sleep outdoors.

Indeed, up and down the state, elected officials are trying to figure out what to do with encampments. The degrees of aggressiveness vary. But they all want to be able to move lots of unhoused people from where they are to other mostly temporary locations, and then clean the streets.

The trend seems driven by a collective understanding that this (mostly) post-pandemic reality of homeless people living everywhere is unsustain-

able. And more important, it’s a tacit admission that, despite the valiant politicking and taxpayer dollars being spent, the permanent and affordable housing that California’s elected officials keep promising as a solution will likely take years, not months, to build.

In that way, the difference between what Steinberg wants to do and what Buscaino wants to do is basically splitting hairs. As it is with what L.A. is already doing by authorizing the clearing of specific encampments around parks and libraries after offering all of the occupants housing or shelter.

There are legitimate questions about whether any of this will turn out to be legal. The Boise vs. Martin decision forbids the ticketing or arresting of homeless people for sleeping or camping on public property unless there is shelter available as an alternative.

These answers will come in time. More immediately, though, there are moral questions that must be answered by Californians.

Does it make sense to

pour most of our resources into permanent and affordable housing? Or does it make more sense to invest in emergency shelters, tent cities and tiny homes?

Is it humane to allow people to live, get sick and, too often, die in encampments, knowing they will likely wait years for housing? Or is it more humane to come up with legally dubious ways get people into shelters, even if it’s sometimes against their will and requires an intervention by law enforcement?

Like Culbertson, I’m conflicted. I realize it every time I drive by those RVs parked along Jefferson Boulevard and see a homeless person stumble from between them into traffic.

I do know that the criminalization of homelessness, whether issuing tickets or something more drastic, isn’t the answer to anything.

“I don’t know what enforcement means,” Culbertson told me. “I hope it doesn’t mean arresting people, because arresting someone for illegal encampments doesn’t solve the problem. It just moves the problem from my house to your house.”

He doesn’t think clearing encampments, a few at a time, willy-nilly, is the answer either. And I agree.

“Just moving someone off the sidewalk doesn’t solve the problem. It solves the problem for the business that has that tent on their sidewalk, but it doesn’t solve the problem for the next business.”

The answer, Culbertson says, is housing. Definitely permanent and affordable housing. Homeless people deserve it, just like everyone does. And homeowners have to be willing to accept it being built in their neighborhoods.

But is it a realistic answer? Can L.A. build housing at the scale and speed that’s needed to make a difference? He’s unsure.

“During the pandemic, you’ve had to make allowances, because there was just not a lot anyone could do. But the city has a lot of money to deal with the homeless problem, and there has been very little permanent housing built.”

Culbertson sighed deeply.

“I think we’re all frustrated.”

Guard is fatally shot as TV news crew covers a theft in Oakland

OAKLAND — A security guard has died after he was shot while protecting a Bay Area television news crew covering a smash-and-grab theft, part of a rash of organized retail crime in the region.

“We are devastated by the loss of security guard and our friend, Kevin Nishita. Our deepest sympathy goes to Kevin’s wife, his children, his family, and to all his friends and col-

leagues,” KRON-TV Channel 4’s vice president and general manager, Jim Rose, said in a statement Saturday.

Nishita was an armed guard for Star Protection Agency and provided security for television news crews in the region, who are often targeted by robbers for their equipment.

He was shot in the abdomen Wednesday during an attempted robbery of KRON-TV’s camera equipment near downtown Oakland, police said.

The news crew was covering a recent robbery involving a group of thieves who broke in and stole from a clothing store.

A reward of \$32,500 is being offered for information that leads to an arrest in Nishita’s killing.

Nishita was a police officer for the cities of Hayward, San Jose and Colma before retiring in 2018. The Alameda County Sheriff’s Office said deputies escorted his body from the hospital with full law enforcement honors.

“This senseless loss of

life is due to yet another violent criminal act in the Bay Area. We hope that offering a reward will help lead to the arrest of those responsible so they can face justice for this terrible tragedy,” Rose said.

The region has been struck by organized retail thefts in which bands of thieves, some carrying crowbars and hammers, break into high-end stores and snatch merchandise.

Similar thefts have been reported in Los Angeles, Beverly Hills and elsewhere

in the country.

At least eight thieves stormed a Home Depot store in Lakewood on Black Friday and grabbed hammers, crowbars and sledgehammers in the tool section before dashing off in a getaway vehicle, the Los Angeles County Sheriff’s Department said.

Four people who may have participated in the Home Depot theft were later arrested in Beverly Hills after officers stopped two cars that were part of a caravan of vehicles driving

around the city’s business district, Beverly Hills Police Lt. Giovanni Trejo said. A bystander called police after seeing that some of the vehicles did not display license plates, he said.

Meanwhile, police in Los Angeles arrested three people suspected of storming a designer clothing store on Melrose Place after stopping a vehicle and seeing clothing in plain view, LAPD Officer Mike Lopez said. He added that more than 10 people ransacked another store on La Brea Avenue.
