The following is adopted as the new CTC for the Contract effective August 21, 2024:

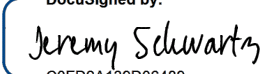
Sourcewell, Virginia Region 3 - Central VA

CONTRACT MODIFICATION

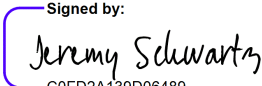
The updated CTC will appear in the eGordian software upon receipt of the executed extension document.
