ITB

Sourcewell issued the Invitation to Bid (ITB) to provide Indefinite Delivery Indefinite Quantity Contracting (IDIQ) on behalf of current and potential Sourcewell Participating Entities, including all government agencies, education agencies to include colleges and universities, and non-profit agencies, within the state of Ohio, as identified in the attached map of the regions. Sourcewell included multiple solicitations within the ITB with the intention of awarding multiple contracts in the state of Ohio. A specified number of contract opportunities were set aside for Minority Business Enterprises (MBE) as listed in the Table of Minority Business Enterprise (MBE) Solicitations in the ITB.

Advertisement

The following advertisement was placed May 23, 2024, May 30, 2024 and June 6, 2024 in *The Columbus Dispatch, the Plain Dealer-Cleveland, Dayton Daily News, Cincinnati Enquirer, and Northwest Ohio-Toledo*. It was posted to the Sourcewell website and the Sourcewell Procurement Portal for daily viewing and document download/response from May 23, 2024, until the scheduled due date and time:

Sourcewell, a State of Minnesota local government entity and public agency, is issuing this Invitation to Bid (ITB) on behalf of its participating entities to create indefinite delivery-indefinite quantity (IDIQ) contracts that may be used by those participating entities for projects related to the repair, alteration, modernization, and rehabilitation of infrastructure, buildings, structures or other real property. It is the intention of Sourcewell to award a specified number of set aside contracts to Minority Business Enterprise (MBE) firms in each region.

Bids are due no later than July 11, 2024, at 4:30 p.m. Central Time, and late bids will not be considered.

Pre-bid meeting

A pre-bid webinar was conducted and broadcast on June 13, 2024, beginning at 9:00 AM CT. A link to the on-demand recording, as well as the presentation slides, were subsequently made available to all registered plan takers.

Bid Evaluation Method

The Sourcewell Bid Review Committee first determines responsiveness and responsibility of all bidders. A responsive bid must have been submitted on time and materially satisfy all mandatory requirements identified in the ITB. The bidders submitted five adjustment factors for each contract opportunity within the region to the fixed prices in the Construction Task Catalog. The submitted bid adjustment factors were weighted as more fully described in the ITB section to determine a single combined adjustment factor. This combined adjustment factor was then used in determining the ranking of the bids. Bidders may not be awarded more than one same scope Contract within a Region. The maximum number of contracts to be initially awarded by geographic region and contract type was identified in the ITB under Article VIII. Evaluation and Award.

Findings of the Bid Review Committee

Bid submissions were reviewed thoroughly according to the ITB Specifications with awards going to the lowest responsive/responsible bidders. The Sourcewell ITB required proposers to upload a current letter from their bonding company dated within six months of the closing date and time of this solicitation. Chase Construction & Development Group, LLC, Superior Flooring, and Prodigy Building Solutions, LLC were found to be non-responsive based on this requirement. The ITB also required bidders to provide six past projects that were performed in the past three-years and be over \$25,000. Quality Masonry Company, Inc. and Regency Construction Services, Inc. were found non-responsive for not meeting this requirement.

Brandstetter Roofing & Remodeling and Madison interiors LLC were found non-responsive for not meeting the bonding letter and past projects requirements. A clarification on the adjustment factors provided by Control Concepts of Ohio LLC was sent and they were found to be outside the competitive range. A clarification was sent to Henderson Contracting Company Inc. on what appeared to be a clerical error with the past projects that were provided. The selected contractors identified in the results below have the required experience with IDIQ Contracting work, and all the awarded bids were determined to be competitive and reasonable for the area.


